Course Overview:

ARTS 1312 Design II (50.0401.5326) (2-4) 3 hours

Develops the skill to create three-dimensional designs using wood, clay, and metals. Introduces the principles/elements of three-dimensional design, plus basic art concepts, techniques, and media essential to the organization and understanding of visual information. (ICOs 1, 4, 5, 6) Prerequisite: None.

ARTS 2326 Sculpture I (50.0709.5126) (2-4) 3 hours

Develops the skill to create expressive sculpture using clay, wood, and metals. Presents advanced art concepts, techniques, and media essential to the organization and understanding of visual information. Lab fee required. (ICOs 1, 3, 4, 5, 6) Prerequisite: ARTS 1312 or instructor approval.

WLDG 1408 Metal Sculpture (48.0508) (2-6) 4 hours

Instruction in the techniques and methods of oxy- acetylene and electric arc welding and cutting to produce metal sculptures. Skill development in welding, brazing, and finishing techniques. Topics address basic shop ethics, artistic styles, and professionalism. Students will acquire and demonstrate skills using cold and hot forming methods, oxy-acetylene cutting, welding and brazing, and basic arc welding processes. Student will be responsible for creating several metal sculptures using various welding procedures. This course may be substituted for a required welding course or a humanities course at the discretion of the department chair. Lab fee required. (ICOs 1, 2, 3, 4, 5) Prerequisite: Consent of department chair.

Course Outcomes Upon successful completion of this course: Students will be able to:

Use Elements of Art and Principles of Design to create objects.

Demonstrate the skill of Oxy-Acetylene Cutting and Welding and Electric Arc Welding.

Compose and complete various three-dimensional assignments.

Course Expectations:

Attendance - Be punctual. Late arrival or early departure will count as an absent.

If you cannot complete your work on due date or miss a group critique session, you will lose a letter grade.
