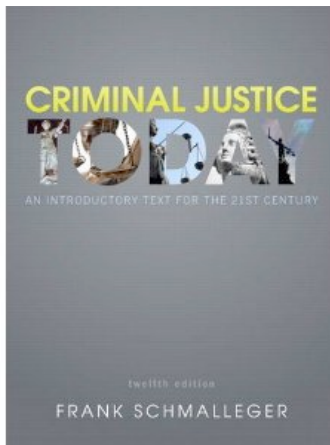

Introduction and Blackboard Orientation Quiz: **10% of final grade**

The first week of the course, you will introduce yourself and tell us a little bit about yourself. (What is your major? Why are you taking this course? What are your future career and educational goals?) Answer these questions and feel free to include any other appropriate information about yourself.

In order to ensure that all students can successfully navigate Blackboard and use the site to successfully complete this course, all students will be required to take and pass a Blackboard quiz before continuing with this course.

Discussion and Attendance: **20% of final grade**

Each Monday morning at 8:00 a.m., a new discussion question will be posted. This discussion will remain open until the following Sunday at 11:30 p.m. so that students

may make comments and/or ask questions of myself or fellow students. These questions will be relevant to the reading material assigned for that week. Your discussion and attendance grade will be based on you logging in to the discussion board and making a contribution to the discussion on four different days between the Monday that the discussion is opened and the Sunday that the discussion is closed. Although I am not requiring a minimum amount of words per post, I do expect your contributions to be more than an 'I agree' or 'Good post.'

Practitioner Interviews: 25% of final grade

These assignments are intended to provide the student with some exposure to the real world of criminal justice. Contact a criminal justice professional (contact information will be provided by the instructor). You will conduct a face-to-face or phone interview with your chosen criminal justice practitioner. A form of suggested questions will be provided to the students. A two page typed, double-spaced paper that contains the summary of your interview with your chosen practitioner must be turned into me on or before December 1, 2012 at 11:30 p.m.

Midterm Exam: 20% of final grade

The midterm will be a combination of multiple choice, essay/short answer, true/false and listing questions. The midterm will be available from 11-05-12 at 8:00 a.m. to 11-11-12 at 11:30 p.m.

Final Exam: 25% of final grade

The final exam will be a comprehensive exam. In other words, your final will cover what you have learned through the entire semester. The final exam will be a combination of multiple choice, essay/short answer, true/false and listing questions. The final exam will be available from 12-08-12 at 8:00 a.m. to 12-12-12 at 11:30 p.m.

Expectations for Engagement – Online Learning

Reasonable Expectations of Engagement for Instructors

 - communicate any changes to assignments and/or to the course calendar to students as quickly as possible.
3. As an instructor, I understand that I need to provide regular, timely feedback to students about their performance in the course. To keep students informed about their progress, I will
 - post grades for discussion postings within one week of the discussion thread closing.
 - provide grades for major assignments within 2 weeks of the due date or at least 3 days before the next major assignment is due, whichever comes first.

Reasonable Expectations of Engagement for Students
