### **Course Description**

MATH 1314 College Algebra (27.0101.5419) (3-0) 3 hours  
Includes in depth study and applications of polynomial, rational, exponential and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability and conics may be included.

1. Demonstrate understanding and knowledge of properties of functions, which include domain and range, operations, compositions, and inverses.
2. Recognize and apply polynomial, rational, exponential, and logarithmic functions and solve related graphs.
3. Apply graphing techniques.
4. Evaluate all roots of higher degree polynomial and rational functions.
5. Recognize, solve and apply systems of linear equations using matrices.
6. Graph and recognize simple conics.
7. Demonstrate understanding of series and sequences and probability.

  - post grades for discussion postings within one week of the discussion thread closing.


















































#### Reasonable Expectations of Engagement for Students
