### **Entries**

All entries should be mailed to, **Regional UIL Director, Odessa College, 201 West University, Odessa, Texas 79764. Phone: (432) 335-6433, FAX: (432) 335-6553, e-mail: [uil@odessa.edu](mailto:uil@odessa.edu)** with the following stipulations:

1. The District Director must certify winners.
2. Certification should include both the full name of entries and the event in which each is entered.
3. **District entries should be mailed to the Regional Director within five (5) days after a district meet, but they must be received by:**

### **Entry Fees**

Participating schools are not responsible for sending entry fees to the Regional Director.

**Each District Director will handle all entry fees for a district and then bill respective schools for the amount owed.** Entry fees for the Regional Meet are as follows:

Regional entry fee for One-Act Play is \$200.00 per play.

Regional entry fees for every other academic contest are \$1125.00.

**An entry fee form is located on page 33 of this handbook.**

## **Contest Results**

It is the responsibility of the contestants, their sponsors, coaches and/or administrators to obtain contest results. Please plan to be present for awards for your event or have someone from your school present. In addition to scheduled announcements, contest results will be posted in the Odessa College Cafeteria, located in the Student Union Building, and the Composite Technology Building as soon as they are tabulated and verified.

## **Contest Graders/Judges**

As specified in contest rules, coaches may be asked to grade and/or judge.

## **Withdrawal and Tardiness**

A school that withdraws a student from the Regional Meet is responsible for notifying the appropriate alternate and the Regional Director. Refunds of entry fees for withdrawals will not be made. Being late to a contest will mean forfeiture of that event.

## **Awards**

Winners' packets will be distributed during the awards ceremonies only. The regional site is under no obligation to mail them to persons who do not attend the awards ceremonies. If a contestant and/or coach or sponsor is not present, the award and/or results will be mailed **ONLY IF A SELF-ADDRESSED, SUFFICIENTLY STAMPED ENVELOPE HAS BEEN LEFT WITH THE CONTEST DIRECTOR**. Individual and team awards will be given in compliance with UIL specifications and guidelines. Region I will also present a Regional Academic Championship to the school with the highest total points, according to Section 902 (n) of the Constitution and Contest Rules book, in all academic events.

## **Food Service & Book Store**

The cafeteria, located in the Student Union building, will be open during the Spring Meet. Breakfast, hamburgers, sandwiches, soft drinks, etc., will be available from 7:30 a.m. until 6:00 p.m. on Saturday, April 14, 2006.

## **Admission Charges**

**Information regarding the 2007 UIL Academic State Meet is posted on the UIL website at [www.uil.utexas.edu](http://www.uil.utexas.edu). Information packets will not be mailed to schools or handed out during the regional meet verification meetings or awards ceremonies. Coaches and contestants must go to the UIL web site for tentative schedule, parking, campus map and other vital State Meet information. Responsibility for knowing times, dates and sites of the State Meet rests solely with coaches and contestants.**

## **SPRING MEET CODE**

The general Spring Meet Code means to:

- (1) Participate in contests in the spirit of fairness and sportsmanship, observing all rules-both in letter and in spirit.
- (2) Sponsor and advise individuals and teams without resorting to unethical tactics, trickery which attempts to skirt the rules, or any other unfair tactic which detracts from sound educational principles.
- (3) Accept decisions of officials and judges without protest and extend protection and courtesy to officials.
- (4) Regard opponents as guests or hosts while placing personal and/or team integrity above victory at any cost. Maintain grace and poise in victory or defeat. Conduct that berates, intimidates, or threatens competitors, based on gender or ethnic origin, has no place in interscholastic activities.
- (5) Provide information or evidence regarding eligibility of any contestant or school to local school administrators or to the appropriate judicial bodies upon request.
- (6) Understand and appreciate the educational values of competition and abstain from modifying or soliciting another teacher to modify grades for eligibility purposes, knowing that such behavior defeats the character-building purposes of extracurricular competition.
- (7) Abstain from any practice that makes a student feel pressured to participate in non-school activities.
- (8) At all times, ensure that competition is relative to a more important overall educational effort, using competition as a tool in the preparation of students for citizenship and successful adulthood.
- (9) Insure that UIL Academic district, regional and state meets receive precedence over non-qualifying contests or meets.
- (10) School districts shall notify the academic district or regional meet director no later than the end of the second school day following academic district or regional competition if a student or a team knows that it will not compete in the next higher academic meet.

A list of absent contestants will be reported to the state UIL office from each academic event. It is vitally important that you notify the Regional Director in advance if a contestant will be unable to attend the regional competition.

## LINCOLN-DOUGLAS DEBATE JUDGING REQUIREMENTS

1. Each school with entries in Lincoln-Douglas Debate must supply one qualified judge, to remain available for assignment as long as debaters from the respective school remain in competition. A “qualified judge” is one experienced in judging Lincoln-Douglas Debate. Schools are to notify the Regional Meet Director of their judge’s name and contact information within five (5) days after their District Meet by no later than **Monday, April 2, 2007.**
2. All debate judges and other personnel **must report to ET 130 at 5:00 p.m. Friday, April 13, 2007**, for assignment.
3. Failure to fulfill the judging obligation will jeopardize the entry of students from the respective school in the Regional Meet.

## INDIVIDUAL EVENTS JUDGING REQUIREMENTS

1. Each school with entries in Individual Events (Poetry, Prose, Informative Speaking, and Persuasive Speaking) must supply one qualified judge to be available for judging in preliminary rounds. A “qualified judge” is one experienced in judging these events. Schools are to notify the Regional Meet Director of their judge’s name within five (5) days after their District Meet by no later than **Monday, April 2, 2007.**
2. All judges for Poetry and Prose should meet in **DH 215 at 7:45 a.m. Saturday, April 14, 2007** for their assignment. Judges for Informative and Persuasive Speaking should meet in **DH 216 at 10:45 a.m.** for their judging assignment.
3. Failure to fulfill the judging obligation will jeopardize the entry of students from the respective school in the Regional Meet.

**In naming judges, it generally does not work for the same judge to judge LD and IE, as rounds tend to overlap.**

## LINCOLN-DOUGLAS DEBATE INFORMATION

It is the decision of the Regional Executive Committee that debate will run on a tournament format rather than on a round-robin format. Places on brackets in Lincoln-Douglas Debate will be predetermined with priority given to keeping debaters from the same school or district separated as long as possible. Initial bracket positions will be determined by place in District Meets, with the side to be debated preset in Rounds I, II, and determined by a coin flip for Round III.

\*\*Debaters at the Regional Meet will compete in three (3) preliminary rounds and elimination rounds. Debaters for elimination rounds will be selected. First, they will be selected on the basis of preliminary rounds won/lost records; second, on the basis of speaker points; and third, on the basis of won/lost records of teams met.

- Quarter-final winners will advance to Semi-finals.
- Semi-final winners will advance to finals.
  - Semi-final losers will debate for third place.

\*At the discretion of the Regional Meet Director, debate formats announced above will result in a shorter or longer schedule and modified brackets. An announcement of any change will be made at the opening meeting.

\*\* If quarter-final rounds are not necessary, the quarter-finals will become semis at 7:30 a.m. and the semis will become final rounds at 8:30 a.m., April 14<sup>th</sup>. (UIL Spring Meet Manual, page 70).

\*\*\* A fifteen minute debate verification for elimination rounds will be held at 10:30 p.m., April 13<sup>th</sup>. One representative from each school will be admitted to verify ballots. **Elimination postings after the verification period are official and final.**

**Please note:** If a school has a regional Lincoln-Douglas Debate qualifier who cannot participate in the meet, the school is obligated to call the Regional Director at 432-335-6433 as soon as possible. See the C&CR, Section 1002 (b) (4).

## ONE-ACT PLAY INFORMATION

### Entry Fee

Participating schools are not responsible for sending entry fees to the Regional Director. **Each District Director will handle all entry fees for a district and, then, bill respective schools for the amount owed.** Entry fee for each One-Act Play is \$200.00.

### Location of Contest

The One-Act Play contest will be held in Deaderick Hall Auditorium, Odessa College. Members of the Odessa College staff will serve as hosts for the One-Act Play competition.

### Performance & Rehearsal Positions

By a drawing, college personnel and the Regional Director will determine the order of performance after completion of area One-Act Play contests. Rehearsal order will be determined by geographic location of participating schools. Performance order will be determined by random draw. All concerned schools will be notified of performance and rehearsal positions the week after area contests. You will be notified as soon as the order is determined. **Please do not call requesting this information.** Questions regarding entries/scheduling of the One-Act Play contest may be directed to Chuck Everett, (432) 335-6664 or [ceverett@odessa.edu](mailto:ceverett@odessa.edu).

A school should report to the stage loading door (at the North side of Deaderick Hall Auditorium) about fifteen minutes before the hour for its rehearsal. A college host will be waiting there to answer questions, to direct the unloading of props, and to assist in every way possible.

### Be On Time

Events will run as scheduled. Failure to report promptly at specified times will result in forfeiture.

### Rehearsals

Each play will have exactly one clock hour on the stage. A One-Act Play group will be permitted to enter stage on the hour and must be off by the end of the hour. A tour of backstage facilities and discussion of procedures will follow each rehearsal.

### The Stage

The acting area on the stage in the Deaderick Hall Auditorium is about thirty (30) feet wide and thirty-one (31) feet deep (from the back wall to the curtain line). The apron of the stage extends about six and one-half (6-1/2) feet beyond the proscenium wall. Plays must be staged against black drapes. There is an orchestra pit in front of the stage. Questions concerning the technical specifications of the stage area should be directed to Chuck Everett, (432) 335-6664, or [ceverett@odessa.edu](mailto:ceverett@odessa.edu).

### Unit Set

Odessa College provides a complete UIL approved One-Act Play set, including the door unit.

### Sound

There is no provision for sound other than an electrical outlet stage right near the light booth for use with a school's own equipment.

### **Lighting**

Lights will be pre-set to cover all areas. **A follow spot will not be provided.** The intensity of lights can usually be regulated to suit specific needs, but elaborate or special color effects cannot be provided. Lights cannot be generally reset or regulated for any one play.

### **Curtains**

A stage crew from Odessa College will be on hand to offer technical assistance. The curtain will be operated by college crew members. The main proscenium curtain will be rigged to travel or fly.

### **Storage**

Some overnight storage space is available for Thursday night. All props must be removed as soon as each performance is over.

### **Dressing Space**

Due to limited dressing and make-up areas, all casts are encouraged to dress and make-up at their motels. Special arrangements can be made for schools not staying overnight. A "green room" will be available but personal belongings cannot be left there after you leave the "green room."

### **Authorized & Unauthorized Personnel**

In accordance with UIL regulations, only students listed in the official Eligibility Notice **excluding alternate(s)** may be in the green room or on the stage area. Only eligible students may participate in any capacity as members of the contest company. This includes helping with costumes and make-up during the rehearsal or performance time at the contest site.

Further, the Regional Meet prohibits all unauthorized personnel from the backstage, stage, or dressing room areas. Unauthorized personnel are defined as alternates, parents, friends, colleagues, or any other persons not specifically authorized by UIL rules and/or the director(s) of the One-Act Play contest to be in designated areas.

**The announcement of winners, the presentation of awards, and oral critiques will follow the last performance as soon as the judge is ready with his decisions. All casts are encouraged to stay for the critique of all plays.**

## GENERAL ATHLETIC INFORMATION

Except for substitutions allowed by the rules, a contestant may enter the Regional Meet only in the events in which he/she qualified in the District Meet.

Contestants must report on time in order to participate in an event. Video-taping of athletic competition is permitted. If filming interferes with competition, officials will ask that all taping cease.

1. All track events will be held at Ratliff Stadium (see map on page 20). All events will be held on all weather surfaces.
2. Outside exceptions listed in the UIL Constitution and Contest Rules, The National Federation Official Rules will govern Track and Field events at the Regional Meet.
3. Coaches will not be permitted on the track during the Regional Meet. There will be no exceptions to this ruling. All unauthorized personnel must remain completely away from the field, and observers must be in the stands at the stadium. The Odessa College trainer will be available at the meet for injuries and other needs. Trainers will be permitted to assist the Odessa College training staff.
4. The shot put area and runway to the discus will not be open to anyone. Any coach on the track or field or in the above closed areas will have his/her team disqualified.
5. Any protest will be interpreted by a qualified individual whose location will be designated. Any protest lodged must be initiated by a school official. If the protest cannot be resolved by the designated individual, the protest will be referred to the referee. The final line of appeals rest with the Jury of Appeals to be established by the regional committee.
6. Only two contestants will qualify for the State Meet. Ties will be broken according to official rules and, only if necessary, by the drawing of lots.
7. Admission to Track and Field events will be \$5.00 for adults and \$3.00 for students and senior citizens. Admission will be valid for the entire day. Participants will not be charged admission. Coaches' passes will be distributed in the coaches' packets. Administrators' passes will be mailed to each high school principal prior to the meet.
8. In accordance with UIL regulations, no workouts will be permitted at Ratliff Stadium prior to the meet. Gates will open at 9:00 a.m. on Friday and 8:00 a.m. on Saturday.
9. Coaches' packets will be available at the shot put weigh-in station beneath the west stands and may be picked up as early as 9:00 a.m. Friday. No packets or heat sheets will be prepared for

final events on Saturday. Coaches' packets will contain five (5) passes.

10. No preliminaries will be held for **the 1600 meter run** or the **3200 meter run**. The finals for these two races will begin with a waterfall start (2 heats with the fastest times running in the second heat).
11. The **800 meter run** will be run in lanes around the first curve and break at the flag when one stride ahead (2 heats of 12 with first two of each heat and next 4 fastest times qualify for finals).
12. The 400 meter relay, 800 meter relay, and 400 meter dash will be run in lanes all the way.
13. The **1600 meter relay** will use a three turn stagger. The first lap will be run in lanes all the way. The second runner breaks for the pole after the first curve.
14. Lane assignments will be posted **Thursday, April 26, 2007, at 5:00 p.m.** near the north entrance of the Odessa College Sports Center. Lane assignments for the finals will be made as soon as possible after Friday's meet and posted on Saturday at Ratliff Stadium. The qualifiers to the final heats will include the top finisher from each preliminary heat and the next five best times from the preliminaries, except the 800 meter.
15. Food, soft drinks, suntan lotion, "warm-ups," jam boxes, and glass containers are not allowed on the field.
16. Spectator seating is allowed on the west side of the stadium only. Special provisions for east side seating will be made for selected events.
17. Contestant ID's are required for admission through the contestants' gate.
18. The Appeals Committee will be available in the press box for both days of competition.
- 19. All Region 1-AAA Schools with students who advance to the regional meet will provide two officials from the school to work events at the track meet (one from the boys' team and one from the girls' team). If you have only one team advancing (boys' or girls' team), then you will provide only one official.**
20. Since we have three heats, we will take the top finisher in each heat and the next five fastest times.
21. All camps must be set up in the east stands. Enter through the northeast gate. Buses can be parked on the east side.

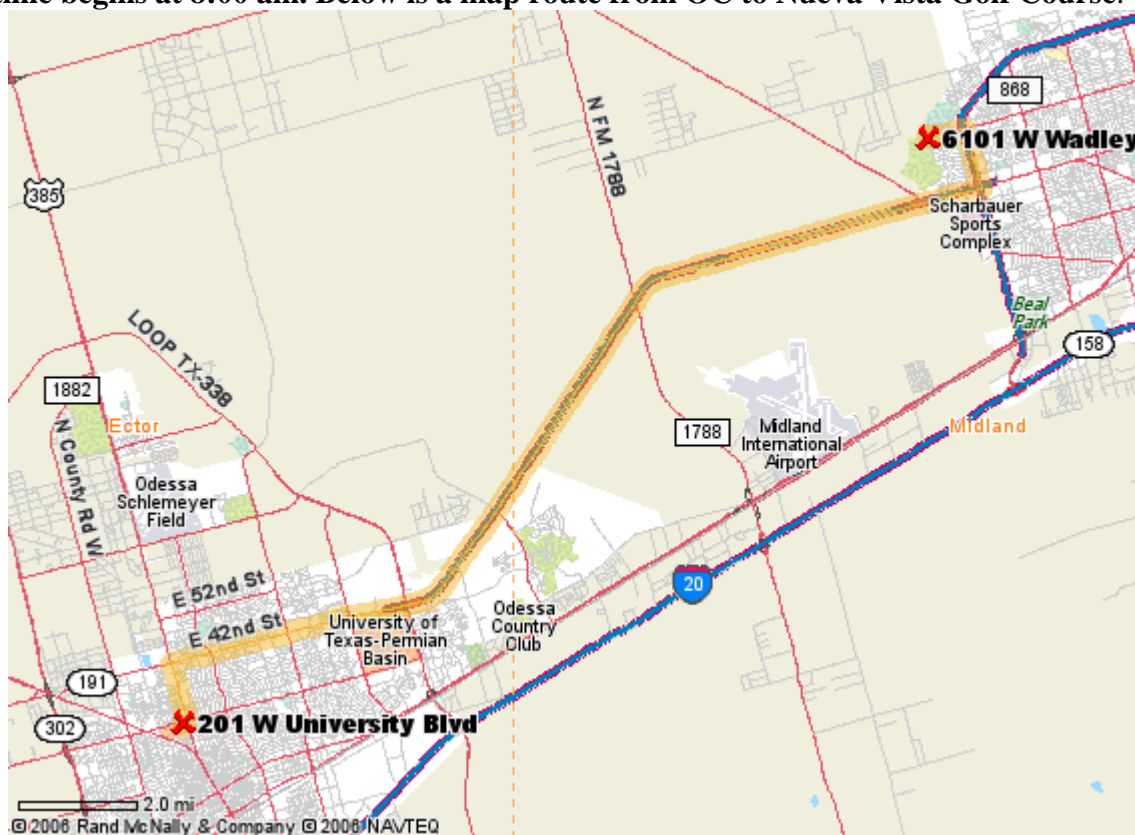
1. The UIL Regional Golf Meet will be held at Nueva Vista Golf Club, Midland, Texas.
2. Each District Director will send the Regional Meet Director all golf entry fees including the green fee of \$15.00 per day per person. District Directors will pay \$500.00 in green fees for two five-person teams, playing two days. Additional medalists will be \$50 each.
3. Play will be governed by USGA, UIL and local rules.
4. In regional and state competitions, the player shall pick up the ball and record a score of 9 after the 8<sup>th</sup> stroke.
5. Individuals and/or teams qualifying for regional are allowed one practice round of 18 holes at the regional site after the individual or team has qualified for the regional tournament (see section 1206 (b) (3) (A) and Section 1260 (g) (7). **The girls' practice round will be Sunday, April 22<sup>nd</sup>.** This practice round may be the Sunday afternoon preceding competition (beginning no earlier than 12:00 noon). **The boys' practice round will be Tuesday, April 24<sup>th</sup> (after the girls' final round).** Schools shall not use more than one hour during the school day for practice rounds. There shall be no more than one day loss of school time involved in practice or travel in relation to practice preceding the tournament. Once a practice round has been completed, neither teams nor individuals are allowed to return to the site on another day to chip and/or putt (see Section 1206). **The cost is paid directly by participating school and is not included in the UIL fee structure. To schedule practice rounds call Nueva Vista Golf Club at (432) 520-0500. .**
6. Tee off times for boys' and girls' teams are 8 am on Mon., Tues., Wed., Thurs. Tee off times will be posted at the golf course on Sunday, April 22nd, after 3:00 p.m. and on the Odessa College website ([www.odessa.edu](http://www.odessa.edu)) as soon as they are available.
7. Coaches, parents and spectators may follow players on the golf course, but should stay a substantial distance from competitors during play. After play has started, coaches, spectators and parents may not coach or "advise" players. **A player is subject to a two stroke penalty on the first offense and disqualification by tournament officials if the coaching continues.** Coaches are allowed, and in fact encouraged, to talk with their players "at the turn" (after 9 holes) as long as starting play on the back nine is not unduly delayed.
8. Students with disabilities, as defined by ADA, must present a waiver approved by the state UIL office before accommodation requests will be honored.
9. Any protest during the tournament must be initiated by a school official.

## Flighting will be as follows:

- A. Team scores submitted from each district will be ranked from lowest to highest, counting only the individual scores of the four best team members.
- B. The ranked list will then be divided into groups of four teams. For example, the team with the lowest ranking score submitted on all entries will be grouped with the next three lowest teams entered, etc.
- C. The lowest scoring individuals from each of the four teams in a group will then be flighted together to form a foursome. The second lowest scoring individuals from each team will comprise the next foursome, etc.
- D. Flighted in this way, each of the first five foursomes will contain a team member from each of the four lowest ranking teams and these foursomes will tee off in sequence so that team members will play the course very close together.
- E. On the second day, teams will be flighted in the manner described above except that rankings will be determined by team scores from the first day's play.

**A coaches meeting will be held at the course on Monday, April 23, 2007, 7:30 a.m. to introduce tournament officials, distribute materials, and discuss local rules.
