### Military Residency Waiver Documents

#### Documents required to meet criteria in Sec. 54.241., subsection:

(b) Military orders (active duty, showing assignment in Texas)

(c) **Military orders** (active duty, showing prior assignment in Texas) AND **proof of continued residency of the spouse/child in Texas** (i.e., leases, monthly utility statements, monthly state or federal aid payments)

(d) **Military orders (active duty, showing assignment outside Texas) AND 6 months' proof of residency of the spouse/child in Texas,** AND EITHER 1) [military member's military form (dated at least one year prior to the start of the term in question and in effect on the first day of that same term) that A) indicates the member's permanent residence address is in Texas OR B) designates Texas as the member's place of legal residence for income tax purposes] OR 2) [member's voter registration card showing Texas for the entire year preceding the first day of the term] OR 3)[a document that shows that the member A) owned real property in Texas for the entire year preceding the first day of the term, OR B) had an automobile registered in Texas for the entire year preceding the first day of the term, OR C) executed a will indicating that the member is a resident of Texas at least one year preceding the first day of the term].

(f) **Death certificate of the military member**, AND **residency documents** of spouse/child showing Texas residency within 60 days of member's death (i.e., lease, utility statements, monthly state/federal aid payments)

(g) **Military orders (active duty, showing assignment outside Texas) AND residency documents** of spouse/child showing Texas residency (i.e., lease, utility statements, monthly state/federal aid payments) **AND letter of intent** of spouse/child to establish residence in Texas.

(i) DD214 (retired/separated military, showing honorable discharge within 1 year) AND items in (d) above

(j) **Prior waiver under another condition AND continuous enrollment (fall/spring terms)** in the **SAME** degree or certificate program (school record check is required)

(k) **Veterans Educational Assistance document** (member, spouse or child) AND, if child or stepchild, **proof of age 25 or younger** on the first day of the term.
