2025/2026 VERIFICATION OF IDENTITY & EDUCATIONAL PURPOSE

Contact the OC Records Office at (432) 335-6404 to insure that your high school or GED documentation is on file. We must verify your high school completion with a **high school transcript**, **GED**, or "**secondary school leaving certificate**" for foreign graduates. If you have enrolled at Odessa College in the past, but have a semester of non-attendance, the transcript or GED may not be on file in the Records Office. Also, Admissions asks transfer students to provide only college transcripts from the other institutions attended. College transcripts are **not** sufficient to satisfy the high school completion requirement unless they show receipt of an associate or bachelor's degree.

OPTION 1 - SIGN IN PERSON AT OC CAMPUS AND ATTACH COPY OF GOVERNMENT ID

The student must appear in person at Odessa College to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to collect the student's ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.
