Parent PLUS loan requirements

1. Complete your financial aid file so that your eligibility for federal aid can be determined.
2. Complete an MPN (master promissory note) online at www.studentloans.gov.
3. Students must have a 2.0 cumulative GPA and have completed 66% of the classes attempted.
4. The parent or endorser must pass a credit check at www.studentloans.gov –(If endorser is needed parent must also complete PLUS Counseling.)
5. The student must be enrolled in at least 6 credit hours before we can certify the loan.
6. OC Student Financial Aid will determine your eligibility for funds based on federal regulations and cost of attendance estimates. The student will receive an award or denial letter.
7. Loan funds are disbursed in 2 payments per semester. The first disbursement is released no earlier than the first day of class and the second disbursement is released at the midpoint of the semester (Mid October for fall & End of March for spring, summer dates vary depending on enrollment). Checks are mailed to the parent address listed above.
8. Parent borrowers may choose to begin repayment 60 days after the last Plus disbursement or defer payments until six months after the date the student ceases to be enrolled at least half-time. Parents may also choose when to repay the accruing interest. Keep in mind that the PLUS interest rate is fixed at 6.31% and an upfront origination fee of 4.276% will be withheld from the loan award.
