An alliance with community/vocational/technical colleges and Ford and Lincoln dealerships, Ford ASSET has trained and placed thousands of new technicians since its inception.

What is ASSET?

The program is dedicated to providing Ford and Lincoln dealerships and their customers with technicians highly-trained in Ford service technologies and diagnostic & repair methods. The program:

- Ensures that ASSET-trained technicians can easily become familiar with new systems and components as they are introduced.
- Allows ASSET-trained students to earn an associate's degree, gain experience and move ahead
 in their careers.

ASSET Program at Odessa College Sewell Auto Tech Center

The Ford ASSET Program is a partnership between Odessa College, the Ford Motor Company and surrounding Ford and Lincoln Dealerships. This partnership was formed for the training and placement of new manufacturer specific service technicians. Odessa College's Ford ASSET Program housed in the brand new "State of the Art" OC Sewell Automotive Training Center will provide the student with both classroom and actual hands-on labs to obtain not only knowledge, but actual Ford Certifications. The 8 week terms used will have the student be on campus for 8 weeks and in their dealership for 8 weeks earning a salary and working with a mentor (Ford Certified Technician) This unique way of education provides the best atmosphere for learning both knowledge and techniques. Plus get paid while learning.

Career & Advancement Opportunities

With the continuous use of electronic systems and on-board computers, there will be constant demand for highly skilled, well-trained automotive technicians. Graduates of this program are prepared to enter the market as automotive technicians. Employment is readily found.

Special Requirements

All courses, other than General Education Requirements, must be completed with a "C" or better. Students should consult with a counselor or advisor for possible degree revisions and for proper sequential order of degree completion. This program incorporates fundamentals important to obtaining employment upon graduation. It may not be suitable if used as a transfer to institutions of higher learning.

General Graduation Requirements

Candidates for any associate degree offered by OC must meet the following minimum degree requirements:

- 1. A minimum of 60 acceptable semester hours must be earned.
- 2. The student must have a cumulative grade point average of at least 2.0.
- 3. Transitional and / or developmental courses do not fulfill any of the above requirements.
- 4. Students will not be permitted to graduate if they have unresolved incomplete (I) grades on their academic record.

DEALERSHIP RESPONSIBILITIES AND COSTS

- Become a sponsoring dealer by signing a Dealer/Student sponsorship form.
- Interview and select prospective student(s).
- Appoint an in-dealership coordinator to assist the ASSET Instructor in planning and monitoring the cooperative work experience.
- Establish the ASSET Student as a dealership employee during the co-op period.
- Negotiate a wage plan with the student, for the student's co-op periods.
- Provide the ASSET student with uniforms consistent with other dealership technicians.
- Attend ASSET supported events or activities.
- Review and verify ASSET student's planner/course completions in STARS at the beginning of each co-op period.

STUDENT QUALIFICATIONS

For a student to be considered for entry into the Ford ASSET Program, the student must meet the minimum qualifications:

- Student must be a high school graduate or equivalent before the start of the Ford ASSET program;
- Student must be 18 years old or older before the start of the Ford ASSET program;
- Student must complete a Ford ASSET program application.
- Student must interview with the Odessa College ford ASSET Instructor and the Odessa College Automotive and Diesel Technology Department Chair;
- Student must meet the Sponsoring Dealership's potential employment requirements (these may include, but are not limited to: possessing a valid Driver's License, submission to a drug test, and submission to a criminal background check).

Ford Motor Company, in cooperation with local colleges, operates the Automotive Student Service Education Training (ASSET) Program. This program is designed to develop entry level Technicians enabling them to repair today's complex vehicles.

The purpose of this letter is to identify your interest in sponsoring a student for the upcoming new class.

COST TO SPONSOR A STUDENT

Your only education-related cost is technician uniforms for the student during the entire two year program. The student will also be hired by the dealership and paid while performing the co-op work. Students are responsible for all tuition, fees and textbook costs. The ASSET program is the most inexpensive way to obtain Ford STST trained technicians – the students pay for the training.

EFFECT ON TRAINING STANDARDS

Throughout their term in the ASSET program, students earn STST credentials as they go, making ASSET students' valuable members of your team during their co-op periods. By the end of the ASSET program, graduates will have completed all courses required in Brakes, Climate Control, Electrical, Engine Performance and Repair, Steering and Suspension, Transmissions, Diesel Engine Performance, and Diesel Engine Repair, specialties and are just one or two courses away from completing *all* STST specialties.
