The Odessa College EMS Department highly recommends that the student study and learn the following objectives throughout the course. These are objectives that the student will be responsible to successfully complete and pass Local, College, State, and National Registry Testing. It would be good practice to work through the objectives, type the question and the answer to have as a study guide for preparation and successful completion of this program.

### **Course Requirements (Lectures, Assignments and Assessments)**

---

Attendance is mandatory any student missing more than 10% of class (3 days) does not meet the state requirements for completion.

There will be a homework assignment on blackboard associated with each chapter. All homework for a unit is due at the time a unit exam is given.

Five unit tests will be given during the semester as well as a comprehensive Final Exam. All testing will be done on Blackboard. A minimum unit exam score of 80 is required to pass each unit. Students who do not score at least an 80 on a unit exam will be required to complete 4 hours of instruction in the student success center with a tutor, they may then retake the exam. A maximum of 2 retests are allowed per unit and 4 retests over the course of the semester. Students failing to achieve a minimum score of 80 on all units and an overall average of 80 will not be eligible to take the National Registry Exam.

Students must be present for all exams. Any student missing an exam for any reason will receive a 0 for that exam and be forced to retake it. This will count as one of the students retests.

The same retesting procedure will be used in the skills lab however all skills are graded as a pass / fail according to criteria established by the National Registry of Emergency Medical Technicians and the Texas Department of State Health Services. Students must successfully pass all skills to take the National Registry Exam.

Due to public safety concerns. Students must maintain a didactic average of 80 to be eligible to participate in clinical activities of EMSP 1160.
