Digital Protocol:

I. ADDITIONAL INFORMATION

Regular, punctual attendance is required for all classes in the Cosmetology program. The Cosmetology faculty believes that attendance and punctuality is required at every session of each course for which the student is enrolled. Therefore, you MUST be present at your assigned time. An attendance policy is included in every course syllabus. When unavoidable circumstances make attendance impossible, students must provide a satisfactory explanation of their absences to their instructor verbally and in writing. Unavoidable circumstances are considered but not limited to: accidents, death, and hospitalization of immediate family members and court ordered subpoenas.

As an Odessa College Cosmetology student, you will be expected to maintain a minimum of 90% attendance for the semester. You will be dropped from the program if you are absent for more than 6 days (48 hours) this semester.

A "tardy" will be defined as:

- missing a total of ½ day (4 hours in total).
- Two (2) tardies will equal 1(one) full absence.

When a Cosmetology student is absent, he/she will receive a recorded absence, against the 90% attendance requirement.

If you are not present for roll call you will be counted absent on your professionalism grade.

Clinic experiences are a vital component of the Cosmetology, Clinic absences are not acceptable. If the student is absent the clinic instructor must be personally notified at least one hour prior to the start of each day.
