Course Overview

Builds knowledge of the world's great civilizations, their art and artists, and the relationship of art to culture from the 1300s to the present. Develops the ability to identify, describe and interpret major works in the history of visual art. (ICOs 1, 2, 5) Prerequisite: None.

Course Prerequisites

You will be required to use variety of multimedia devices as well as random items and tools to complete your assignments:

- -Computer with internet access
- -Ability to send/receive email
- -A digital camera (can be your phone as long as you can upload images to the computer)
- -Media Player (Check the system requirement for MyArtsLab)
- -Random household items and tools

Outcomes Upon successful completion of this course:

Students will be able to identify artworks and artifacts of major time periods, cultures, concepts, and artists.

Students will be able to interpret the concepts historical periods and cultural context of artwork/artifacts.

Students will be able to design their own artworks from the interpretation.

Students will be able to demonstrate and construct their own artwork from the design.

Students will be able to critique other people's work.

Learning Community

Discussion Expectations

However, there will be a discussion for each activity, so that everyone understands what to be expected. If there are questions, opinions, answers to other people's questions, post comments.

Consistency: Be consistent! Let's not procrastinate! If you encounter a problem, don't wait! Let's put your concern on the discussion board. I will do my best help you. If I cannot help, I will find someone to assist you. In the best situation, you can help each other.

BeClear: Because we cannot see each other, it is very difficult to read into your comments fully. This is the class you want to help each other, not to confuse and hurt people. If someone asks you for a clarification, please do so..., elaborate, expand, and ever be so clear!

Don'tbeinappropriate: This course surveys from 30,000 B.C. to Gothic period... That means we will be discussing about race, gender, age, religion, sexual orientation, and etc... I will be monitoring the discussion closely. If someone gets out of line, I may close and/or delete the thread of discussion. If you grow any concern about the subject or what has been said, please let your instructor know immediately.

Assessment

Grading will be based on the chapter exam, discussion board activities, discussions. Late assignment will lower your possible points significantly.
