#### ASSIGNMENTS

##### Attendance

Students are expected to attend class regularly. Attendance will be recorded using a quiz on Blackboard and account for 10% of the final grade. Excessive absences will be grounds for disciplinary action, and will be determined on a case-by-case basis.

##### Sessions

The first two assignments that appear are called sessions and are used to teach you how to use different parts of the Microsoft Office software. Your book will provide you with extremely detailed instructions on how to complete these assignments. It is important that you read each word of the instructions and follow them exactly in order for your assignment to be correct. When you finish your first session click on the folder and it will take you to the "drop box" which is where the assignment is turned in. Click "browse my computer" and find the

file you want to attach (if there is more than one document repeat until they are all listed) then scroll down and click “Submit”. The next screen will give you the opportunity to see what is being submitted so if the information is correct click “ok” and the assignment will be sent to me. Repeat the same process in order to turn in the second session assignment and move on to the Case Project!

### Case Project

Case Projects are like a quiz (open-book) over what you just learned during the completion of the two Sessions. Case Projects will use the techniques that you practiced but the Case instructions from SAM will be much more vague forcing you to rely on your newly gained skills. The Case Projects will also be turned in on a completely different website called SAM. The Course Documents link provides detailed instructions on how to set up your account. When you are ready to complete the Case Project you must log in to SAM and click “SAM Assignments” located on the left hand side of the screen. Click on the assignment you are ready to complete and a screen will appear giving you information about the assignment and the possible number of attempts. The next screen will allow you to download the instructions as well as a blank document for you to complete the project in. It is imperative that you use the blank document provided to complete the work. The reason for this is because the SAM will automatically grade your submission and ensure that the document you are submitting is actually completed by you. You must submit your Case Project by browsing your computer and attaching the file. You may then view the results of your submission and see your grade. A report detailing all of the errors made will also be available. I am allowing multiple attempts so if you are not satisfied with the first grade you may look at the report, fix errors, and resubmit. Please remember that this is a different program from Blackboard therefore I have to manually move your grades over. I will review the submissions weekly and place the highest grade in the Blackboard grade book so do not panic if the information is not immediately correct.

### Research Project

The research project will be assigned towards the end of the semester. The objective is to demonstrate the knowledge you have gained from the class and apply it to a real world situation.

### Final Exam

The final exam will cover all of the different aspects of Microsoft Office explored during the semester.
