Catalog Description: A developmental course that introduces elementary algebra with some arithmetic review. Includes signed numbers and rational numbers with operations through exponentiation; algebraic expressions and their operations; linear equations and inequalities including applications, graphs. The student will learn to select appropriate mathematical techniques and technologies and use skills in information organizing, processing, planning, and problem solving.

Textbooks & Softeware: Elementary and Intermediate Algebra by Bittinger, Ellenbogen, & Johnson, 5th edition, the Student Workbook, and the MyMathLab Software.

Attendance: Student attendance and participation at every class is expected. **Attendance in a developmental course is mandatory**. You will receive ½ of an absence if you arrive late, leave early, or don't have the necessary material for class. You will also be counted absence for sleeping during class. The number of absences is limited to 7 total absences for the semester. Once a student exceeds the number of allowable absences, he/she will receive an F in that developmental class. Please do not simply stop attending class without visiting with me first.

Co-requisite: You are required to attend the Math Lab, ET 120, to obtain a minimum of 14 clock hours per semester. You may use this time to work on homework, study, or get tutoring. A separate lab syllabus will be provided with more information.

Quizzes: Frequent quizzes will be given over any previously covered material. No make-up quizzes will be allowed, but only the 10 best quiz scores will be used.

Homework: All homework for this course will be completed using the MyMathLab software. The homework for this class can be accessed through the Course Compass website at http://pearsonmylabandmastering.com. The Course ID for this class is walker59943. There will be an assignment for each section of the book covered. Each chapter's assignments will be due

on the date of the chapter exam. Computer access is available several places on campus including the Math Lab (ET120) and the Learning Resource Center (Which is open 7 days a week). **NO LATE WORK WILL BE ACCESSIBLE OR ACCEPTED.**
