Course Description: Class Piano is a course for all music majors designed to present basic musical knowledge as applied to the keyboard and to develop basic skills related to playing the piano through both class and individual participation. Fundamental keyboard skills will include sightreading, transposition, scales, chords, harmonization, arpeggios, ensemble playing and solo repertoire. Required of all music majors.

- Required: Scale Skills, Book 4
- Required: One : or 2 inch, 3-ring binder. All supplemental materials given to you in class should be put in your piano binder. Bring binder (along with the other 2 required books) to EVERY class.

Course Objectives: To provide the non-pianist music major fundamental keyboard skills which include sightreading, transposition, scales, chords, arpeggios, harmonization, ensemble playing and performance of solo repertoire.

Course Requirements: Consistent class attendance is extremely important. Consistent practice outside of class as instructed is required. OC provides both electronic and acoustic pianos for "homework" practicing.

Exams: You will be given a weekly grade on assignments given. The Spring semester will cover material taken from Units 16 through 30 of your Group Piano Book. The Final Exam will be a combination grade and will be based on a skills exam and any solo repertoire pieces assigned to you during the semester.

Attendance: You will receive a daily grade **B** either a 100 or a 0. You get three free absences, i.e., three 0=s will be dropped at the end of the semester.

Piano Recital: Performance on the OC Departmental Piano Recitals is not mandatory, but is encouraged. Recitalists will be chosen by Ms. Bizzell based on performance readiness.

Grading Policy: Final grades for the course will be based upon attendance and your willingness to complete the assignments given, calculated as follows:

Attendance:	30%
Weekly Assignments:	50%
Final:	20%

Expectations for Engagement provide the parameters for reasonable engagement between students and instructors for the online learning environment. Students and instructors are welcome to exceed these requirements.

Reasonable Expectations of Engagement for Instructors

1. As an instructor, I understand the importance of clear, timely communication with my students. In order to maintain sufficient communication, I will
 - provided my contact information at the beginning of the syllabus;
 - respond to all messages within 24 hours if received Monday through Thursday and within 48 hours if received Friday through Sunday; and,
 - notify students of any extended times that I will be unavailable and provide them with alternative contact information (for me or for my supervisor) in **case of emergencies during the time I'm unavailable.**
2. As an instructor, I understand that my students will work to the best of their abilities to fulfill the course requirements. In order to help them in this area, I will
 - provide clear information about grading policies and assignment requirements in the course syllabus, and
 - communicate any changes to assignments and/or to the course calendar to students as quickly as possible.
3. As an instructor, I understand that I need to provide regular, timely feedback to students about their performance in the course. To keep students informed about their progress, I will
 - post grades for discussion postings within one week of the discussion thread closing.
 - provide grades for major assignments within 2 weeks of the due date or at least 3 days before the next major assignment is due, whichever comes first.

 - return classroom activities and homework within one week of the due date and

- missing class when a major test is planned or a major assignment is due;
 - having trouble submitting assignments;

 - having my work or childcare schedule changed so that my classroom attendance is affected.

- seek out help from my instructor and/or from tutors;
 - ask questions if I don't understand; and,
 - attend class regularly to keep up with assignments and announcements.
