"Cheating on a test" shall include:

- Copying from another student's test paper
- Using test materials not authorized by the person administering the test.
- Collaborating with or seeking aid from another student during a test without permission from the test administrator.
- Knowingly using, buying, selling, stealing or soliciting, in whole or in part, the contents of an unadministered test.
- The unauthorized transporting or removal, in whole or in part, of the contents

of the unadministered test.

- Substituting for another student, or permitting another student to substitute for one's self, to take a test.

3. As an instructor, I understand that I need to provide regular, timely feedback to students about their performance in the course. To keep students informed about their progress, I will
 - post grades for discussion postings within one week of the discussion thread closing.
 - provide grades for major assignments within 2 weeks of the due date or at least 3 days before the next major assignment is due, whichever comes first.

Reasonable Expectations of Engagement for On-Line Students

1. As a student, I understand that I am responsible for keeping up with the course. To help with this, I will
 - line up alternative computer and internet access in case my primary computer crashes or my internet services is unavailable;

Digital Protocol

Grading Scale for Timed Writings is as follows:

45-50 nwpm--A

40-44 nwpm--B

35-39 nwpm--C

30-34 nwpm—D

Nwpm=net words per minute To figure NWPM take the wpm you achieved and deduct 2 points for every 1 mistakes you made. EXAMPLE: You keyed 50 wpm. You made 5 uncorrected errors. You NWPM=40 (5 errors X 2 pts=10 word deduction).

Schedule of Assignments

Plan to do 2-3 lessons each day to stay on schedule. Each lesson takes at least an hour to complete depending on your keyboarding skill level.

Beginning EVERY lesson, READ the entire lesson, complete the warm up, skill building exercises, all 5 minute timings, and ONLY what is listed below for the individual lessons. You MAY choose to do extra drills or repeat drills or exercises, but what will be graded is listed below. You won't be doing all of the exercises due to time constraints.
