Course Description

MATH 1316 Plane Trigonometry (27.0101.5319) (3-0) 3 hours
Presents trigonometric functions, formulas, solutions of right triangles and applications, variations of functions with changes in angles, trigonometric equations, identities, solutions of oblique triangles and applications, logarithmic functions, inverse functions and complex numbers. The student will learn to select appropriate mathematical techniques and technologies

and use skills in information organizing, processing, planning and problem solving. The student should be able to probe for mathematical meaning and, perhaps, describe these meanings to others.

Prerequisites/Co-requisites

Prerequisite or co-requisite: MATH 1314 passed with a C or better or equivalent competency, or an independent school district/OC dual enrollment form.

Course Objectives

Upon successful completion of this course, students will:

1. Compute the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.
2. Graph trigonometric functions and their transformations.
3. Prove trigonometric identities.
4. Solve trigonometric equations.
5. Solve right and oblique triangles.
6. Use the concepts of trigonometry to solve applications.

Odessa College Policies

Tuition Discounts

The "First Course is Free" discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College.
