Course Description

Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights. All material in the textbook/lectures is testable and it is your responsibility to read the chapters.

Course Student Learning Outcomes

1. Explain the origin and development of constitutional democracy in the United States.
2. Demonstrate an understanding of our federal system.
3. Describe separation of powers and checks and balances in both theory and practice.

4. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government.
5. Evaluate the role of public opinion, interest groups, and political parties.
6. Analyze the election process.
7. Describe the rights and responsibilities of citizens.
8. Analyze issues and policies in U.S. politics.

Course Prerequisites:

Pass Reading on THEA, Compass, or other state-approved alternate test.

Course Assignments:

**Tests & Final Exam:** There will be a total of four tests- All exams will cover four chapters, and Test 4 is the Final which is not Comprehensive (All chapters). It is imperative that students complete the reading assignments in order to be better prepared for the exams. The tests will consist of 25 multiple choice questions valued at 4 points each. The exam will only be available for a specified time period and once you start the test you will have 1 hour to complete it. The exams can be taken up to three times, and the highest grade of the three attempts will be recorded. This is an open-book test and all test questions will come out of the textbook.

**Extra Credit:** In this age of technology it is imperative that college students master the art of internet research, therefore for every exam up to ten extra credit points can be earned if the student submits to me a summary describing a website they found pertinent to the test material- DO NOT use websites such as Wikipedia, Dictionary.com, etc.- Actually research a site related to the material. The assignment should include: 1) URL, 2) date accessed, 3) author and/or organization that maintain the site, and 4) 2-3 sentences on your opinion of the webpage. **The extra credit assignment due dates are posted**, and only one extra credit assignment can be turned in per test. The assignment must be posted in the proper Discussion Board thread.

**Discussion Posts (DP):** The student will be responsible for posting eight original posts and replies on the discussion board for this course (Posts and replies need to be properly cited). Original posts must be at least 250 words in length and should respond to the questions posed for each section.

Additionally, all students are required to respond to one of their classmate's original posts- The reply should be at least 100 words in length and cannot simply be "I agree" or "Great comment" statements. When posting/replying, it is ok to disagree with someone's comments (that is what higher education is all about), although please be considerate and polite to your fellow classmates- Rude and derogatory comments will not be tolerated and will result in 0 points for that assignment.

**Supreme Court Case Review (SCCR):** The student will be responsible for submitting a review on their chosen US Supreme Court case. SCCRs should be at least 500 words (See breakdown below; 400 SCCR and 100 reply), and are at a "First Come First Serve" basis meaning that no two students can complete their review on the same court case- It is the student's responsibility to ensure their post is not the same as one that has already been posted. I **HIGHLY** recommend you "call dibs" on your chosen court case by listing it in the "Chosen SCCRs" tab (Under "Coursework" then "Review Assignments") so other students do not take your court case. The review will be at least 500 words, and will be graded based on the following criteria:

- 1) Background summary- In at least 100 words tell me the history of this court case (10%).

2) Constitutional question & Outcome- In at least 50 words tell me what the Supreme Court was ruling on, and the result of the case, including the Supreme Court's justification (10%).

3) Your opinion- In at least 250 words tell me your opinion of this case. Why do you think it was significant (50%)?

4) Reply to at least one of your classmate's post- The reply should be at least 100 words (20%).

**Optional Current Topic Review (CTR):** This assignment is optional, although worth up to 50 additional points. The student will be responsible for submitting a review on their chosen current topic pertinent to American Government- Your topic does not have to be about an event that occurred in the United States, it could be an international issue, although make sure you discuss how it can affect America. CTRs are at a "First Come First Serve" basis meaning that no two students can complete their review on the same topic- It is the student's responsibility to ensure their post is not the same as one that has already been posted. I **HIGHLY** recommend you "call dibs" on your chosen current topic by listing it in the "Chosen CTRs" tab (Under "Coursework" then "Review Assignments") so other students do not take your current topic. The review will be at least 500 words, and will be a brief summary but **mainly** your opinion of a current topic chosen by the student, and should include possible solutions and consequences that can occur- It will be graded on topic, content, and grammar. Some examples of topics are: abortion, gay marriage, texting while driving. You will post your CTR (Properly cited) at the designated discussion post thread- No replies are required. Below are some items of consideration to help your grade:

1) Was your review mostly a summary? If it was it should have been mostly your opinion.

2) Was your review at least 500 words in length?

3) Did you cite your assignment?

4) Did you proofread (How many typos, etc. did your assignment contain)?

5) Did you tie your topic to policy/government, and include solutions or consequences?

## Odessa College Policies

### Tuition Discounts

The “First Course is Free” discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College.

The “Academic Progress Discount” provides a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. It provides a 20% discount upon completion of 45 credit hours until reaching 60 credit hours. Student must maintain a 2.0 GPA to remain eligible for the discount.

### Academic Policies
