**Title:** EPCT-1341, Principles of Industrial Hygiene

**Course Dates:** 14 January – 6 March 2015

**Course Credits:** 3 Credits

**Location:** On Blackboard (Web Course)

**Course Description:** EPCT 1341 is a 3 hr -credit course that provide basis for understanding the concepts in threshold limits, dose response, and general recognition of occupational hazards, including sampling statistics, calibration, and equipment use. The student will explain terminology and discuss concepts of industrial hygiene and toxicology; describe the anatomy and function of the routes of entry; explain the workings of the major body systems; identify major health hazards found in the workplace and discuss their effects; apply threshold limit values and other appropriate workplace exposure standards; and prepare a report based on research and investigation of an area of industrial hygiene. (ICOs 1, 2, 4, 5, 6)

**Course Prerequisites:** None.

1. Explain terminology and discuss concepts of industrial hygiene and toxicology
2. Describe the anatomy and function of the routes of entry
3. Explain the of the major body systems

5. Apply threshold limit values and other appropriate workplace exposure standards
6. Prepare a report based on research and investigation of an area of industrial hygiene

## Odessa College Policies

### Tuition Discounts

The ***"First Course is Free"*** discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College.

The ***"Academic Progress Discount"*** provides a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. It provides a 20% discount upon completion of 45 credit hours until reaching 60 credit hours. Student must maintain a 2.0 GPA to remain eligible for the discount.
