Applicants for competitive entry programs in nursing must satisfy minimum criteria in order to be eligible for consideration of ranking.

ADN Nursing applicants are required to meet the following *minimum* requirements:

ADMISSION TO ODESSA COLLEGE:

- Must have a High School Diploma or GED.
- Enrolled at Odessa College as a Credit Student. Complete the [Applytexas.org](https://www.applytexas.org) application if you are not currently an OC student.
 - o Must be TSI College ready. (For more info, please contact Odessa College Admissions office.)

REQUIRED TEAS TESTING:

Call Testing Center at 432-335-6620 for details and scheduling

- Testing can be taken up to 3 times in a calendar year (January 1—December 31). It is highly recommended that there be a two-week waiting period before re- testing, however applicants may retest at their discretion. Additional attempts must be approved by the director.
- Applicants can schedule a tutoring appointment by visiting www.odessa.edu/lrc, selecting “Schedule Tutoring Appointment” and choosing “TEAS English and Reading” or “TEAS Math” to meet with a tutor. TEAS workbooks are available for student use in the LRC as well.
- Scores are valid for 3 years; highest scores will be taken. Applications will not be accepted if minimum scores are not achieved. **ALL TESTING MUST BE DONE IN PERSON AT A CERTIFIED TESTING CENTER. ONLINE PROCTORED ATTEMPTS WILL NOT BE ACCEPTED.**

NEW: ALL APPLICANTS APPLYING FOR ANY APPLICATION CYCLE AFTER APRIL 1, 2026, WILL BE REQUIRED TO TAKE THE HESI A2 EXAM PRIOR TO APPLYING. TEAS scores will no longer be accepted.

REQUIRED HESI A2 TESTING:

Call Testing Center at 432-335-6620 for details and scheduling.

- Testing can be taken up to 2 times in an academic year with a 30-day waiting period between tests. **ALL TESTING MUST BE DONE IN PERSON AT A CERTIFIED TESTING CENTER. ONLINE PROCTORED ATTEMPTS WILL NOT BE ACCEPTED.**
- Applicants must complete the reading, grammar, math, anatomy & physiology, and critical thinking components.
- Scores are valid for 2 years.
- Highest scores will be taken. Scores cannot be pieced together (e.g. "super-scored")
- Applications will not be accepted if minimum scores are not achieved.

GPA REQUIREMENT:

- Minimum overall GPA of 2.5 or higher for your application to be considered.
- All official transcripts for previous education must be on file with the Odessa College Records Office. After acceptance to Odessa College, unofficial transcripts are acceptable to the nursing department.
 - o Foreign Students: Transliteration of all foreign coursework is required.
 - o Transfer Students: Make sure to complete the “Evaluate my Transcript” form with the Records Office prior to submitting your nursing application.
- All applicants must complete a Transcript Checklist with a School of Health & Sciences Academic Success Coach prior to application submission. See program application document for more information.

**Applicants are encouraged to speak with a Success Coach regarding substitutions for ENGL 1301 and HUMA courses*

- BIOL 2401 & 2402 must be completed within the last 5 years from application time. If a student has taken BIOL 2401 & 2402 more than once, the average of the last 3 attempts within the 5-year window will be taken into consideration for eligibility.
- All pre-requisite courses must be successfully completed with a “C” or better.
- Course substitutions for prerequisite courses must be approved by the Director of Nursing. Applicants are encouraged to speak with a Success Coach for a transcript review.
 - o HUMA course substitutions will be cross referenced to HUMA 2319, 2323, 1305 courses offered by Odessa College and must meet specific criteria.
- Attendance at a Nursing Program Information Session is **mandatory** prior to submitting an application. The session must be specific for the cohort you are applying for. Failure to attend a session will result in automatic rejection of your application. Please see the ADN website and/or speak with an Academic Success Coach for dates.

ADDITIONAL INFORMATION:

- Proof of active or veteran military status will receive 2 additional points.
- **LVN-RN Transition Applicants:** Proof of graduation from an accredited LVN program and current unencumbered license to practice nursing. A student who graduated from the Odessa College Vocational Nursing program will receive 2 additional points. An active LVN license must be maintained throughout enrollment in the program.
- *LVN-RN transition applicants will not receive points for military and OC graduate status. The maximum amount of additional points granted will be 2 points.
- It is highly recommended, but not required, that applicants submit any healthcare documents for clinical clearance that may be completed with the initial application. See Clinical Clearance Requirements in the Post Admission Requirements section below.
- **Night and weekend clinical rotations may be required in the program. This information will be**

communicated to students in a timely manner throughout the program.

APPLICATION POINT RANKING SYSTEM

As part of the admission criteria, the point values for all nursing applicants will be totaled. A rank ordered list of nursing applicants by point total will be developed. The applicants with the highest number of points will be admitted into the nursing program each semester until all available spots are filled.

Points are calculated based upon the following criteria:

Grade Point Average (GPA):

For point ranking purposes, the GPA will be based on the average of the grades achieved on the five required pre-requisite courses completed within the nursing program plan of study. The applicant's GPA will be determined in the following manner:

The Odessa College Associate Degree Nursing program is licensed by the Texas Board of Nursing. Odessa College does not discriminate on the basis of race, color, national origin, religion, gender, age, disability, veteran status, sexual orientation or gender identity

POST ADMISSION REQUIREMENTS:

Students are responsible for the following requirements AFTER accepting a seat in the program:

- ✓ PROGRAM ORIENTATION: a one-day in person orientation is mandatory. Failure to attend results in the forfeit of the applicant's seat in the program.
- ✓ Uniforms, Specialized Equipment, and Lab Supplies required for clinical. Students will receive information after acceptance.
- ✓ CLINICAL CLEARANCE REQUIREMENTS:
 - Tetanus-diphtheria- 1 dose of tetanus-diphtheria toxoid (TD) is required within the last 10 years. The booster dose may be in the form of a tetanus-diphtheria-pertussis containing vaccine (Tdap).
 - Measles, Mumps, and Rubella Vaccines-
 - o Students born on or after January 1, 1957 must show, prior to patient contact, acceptable evidence of vaccination of two doses of a measles-containing vaccine administered since January 1, 1968 (MMR Vaccine).
 - o Students born on or after January 1, 1957 must show, prior to patient contact, acceptable evidence of vaccinations of one dose of a mumps vaccine.
 - o Students must show, prior to patient contact, acceptable evidence of one dose of rubella vaccine.
 - o Serological confirmation is acceptable.
 - Hepatitis B Vaccine- students are required to receive a complete series of hepatitis B vaccine prior to the start of direct patient care or show serologic confirmation of immunity to hepatitis B virus.
 - Varicella Vaccine- students are required to have received one dose of varicella (chickenpox) vaccine on or after the student's first birthday or, if the first dose was administered on or after the student's 13th birthday, two doses of varicella (chickenpox) vaccine are required. Serological confirmation is acceptable.
 - Flu Vaccine- current during every flu season (October-March).
 - Negative Initial and Annual Tuberculosis Screening.
 - COVID-19 vaccine. Students are required to be fully vaccinated or have an approved exemption. Please contact the nursing department for un-vaccinated status. *Waivers are completed after acceptance*
 - Maintenance of current CPR - Basic Life Support Certification (American Heart Association, ONLY) after acceptance into the program
 - Clearance by acceptable Drug Screening at program admission, or upon return from break in enrollment, and additionally throughout the program. **These are scheduled by the program.**
 - *This requirement is not completed until after acceptance. * Authorize the Board of Nursing to conduct a criminal background check. This procedure is required for students to go the clinical facilities. Information regarding this process will be given upon acceptance. Certain offenses on the student's background check, if applicable, may prevent them from receiving clearance as required by the nursing program, and may result in program dismissal.
