GENERAL NURSING STUDENT POLICIES

Notice of Ineligibility for Licensure

The Texas Board of Nursing (BON) has been given the authority by law to protect the public from incompetent or unsafe nurses. Part of their mandated responsibility is to screen individuals applying for their Student Nurse license. Graduation from the Odessa College Nursing Programs does not constitute eligibility to sit for the state licensure Exam. Odessa College considers student ability to obtain licensure during the admission processes and will fully abide by Texas HB 1508 if students are knowingly admitted to a program when they are ineligible for initial licensure, unless the Student Nurse did not fully disclose or obtain proper authorization prior to program start. Please work with your Program Director for additional guidance. Though you are not required to disclose any sensitive information and any confidential details will not be held against your application status.

In accordance with the laws of the State of Texas, specifically the Texas Nursing Practice Act, notice is given to students who intend to apply for registration as a professional or vocational nurse that all applicants for licensure are required to answer the questions available at the Board of Nursing website: Licensure Eligibility. If the student/applicant answers yes to any of the questions, or in any way question his or her eligibility to take the licensing exam upon successful graduation from nursing school, the student/applicant must petition the BON for a Declaratory Order, which may take up to three months to process. Upon receiving the Declaratory Order, the graduate nurse can take the Nursing Licensure Exam and, under most circumstances, will receive a permit to practice as a Graduate Nurse (GN) or a Graduate Vocational Nurse (GVN). Information pertaining to the Declaratory Order Process is available at: [TBON Declaratory Order](#). Be advised that the BON requires fingerprint identification to screen all applicants for licensure. Fingerprints are obtained after the time of acceptance into the nursing program. Each individual's fingerprints are analyzed by the FBI and there must be clearance on the background check by the BON.

Mechanisms for input may be through student government, ad hoc student feedback at monthly Departmental Meetings, student representation on the Advisory Committee, course and program evaluations, or in person to faculty, the Director of Nursing, or the Dean of Health & Sciences.

PROGRAM FOUNDATION AND CURRICULAR FRAMEWORK

Mission Statement Odessa College Nursing

The mission of the Odessa College Nursing Programs is designed to lead the way in preparing nursing students for practice in a multicultural community within a diverse and changing health care environment; advance the practice of nursing; and provide quality, comprehensive health care in a competent, caring and compassionate manner.

Odessa College Nursing Vision Statement

The Odessa College Nursing Programs will advance the practice of nursing in our diverse and evolving communities of care through increased education of our nursing workforce and fostering the application of management principles, evidence-based practice, and compassionate leadership to improve health outcomes.

Definition of Professional Nursing Education

Professional nursing is an art and science, which emphasizes, promotes, and maintains health and wellness, utilizing evidence-based practice and patient centered care in a multicultural environment. The registered nurse meets the needs of the patient and family with caring, dignity and competence as a compassionate advocate. The nurse demonstrates professionalism, leadership and clinical judgement by utilizing collaboration, informatics and safe practices while providing patient-centered care.

Upon successful completion of all Associate degree RNSG courses with a minimum grade of “C” in each course, the student will receive an Affidavit of Graduation signed by the Program Director

which is required for eligibility to test for NCLEX-RN certification with the Texas Board of Nursing.

Definition of Vocational Nursing Education

Nursing education incorporates a student-centered process of learning that utilizes available resources, nursing courses, and general education courses that promote competency, accountability and professional development.

Upon successful completion of all Level 1 Certificate Vocational Nursing VNSG courses with a minimum grade of “C” in each course, the student will receive an Affidavit of Graduation signed by the Program Director which is required for eligibility to test for NCLEX-PN certification with the Texas Board of Nursing.

Curricular Design Principles

Programmatic Components

Concepts are taught from a simple to an advanced level throughout the nursing curriculums. The nursing programs are organized into three major components: general education courses, biological and social sciences courses and nursing courses.

NURSING COURSE COMPONENTS

The nursing courses are further organized into three (3) distinct areas: theory, skills laboratory, and clinical laboratory. The theoretical portion of the nursing curriculum presents concepts and knowledge essential to the practice of nursing. The skills laboratory portion of the curriculum allows the development of manual skills required for nursing practice. The clinical laboratory portion of the curriculum provides the opportunity to apply both knowledge (theory) and skills in the direct care of clients.

The curriculum is designed to provide the student with a theoretical framework on which to base nursing interventions; a way of processing information to arrive at competent decisions, as well as competence in psychomotor skills basic to nursing practice.

EVALUATION OF TEACHING EFFECTIVENESS (RN TO BSN)

Students in the RN to BSN programs will be evaluated with different modalities including:

- Assessment of student learning outcomes: SLO will be evaluated in each course and based on assignments, quizzes, and presentations.
- Peer and Instructor Feedback: students will be evaluated based on feedback from their peers (group work) and instructors. Classmates will provide constructive feedback based on how they performed during group assignments. Instructors will also provide feedback based on assignments, discussions, projects, and portfolios.
- Program Student Learning Outcomes (PSLO): PSLO will be introduced and reinforced at the beginning of the program-NURS 3244, NURSING 3210, NURS 4314, NURS 3354, NURS 4341, and NURS 3351. PSLOs will be reinforced at the end of the program-NURS 4455, NURS 4354, NURS 4323, and NURS 4457.
- Clinical Performance Evaluations: Clinical course grades are a Pass (PA) or Fail (F). Students will be assessed on their ability to perform in the clinical settings which include direct observation, simulation assessments, and feedback from clinical instructors and preceptors.

- Portfolios: Students will compile a list of their literature review, research and data.
- Capstone Project: NURS 4354, students will integrate knowledge learned from their previous coursework into a comprehensive project that prioritize and apply evidence based on compassionate care for individuals and communities, integrating leadership and patient-centered care approach in healthcare delivery. Also, students will summarize the impact of healthcare policy, advocacy, community & public health, and legal issues on healthcare delivery. In addition, students will be assessed on how they used good communication skills to advocate for evidence-based care within the healthcare team.

Implementation of the Nursing Curriculum is Based on the Following Principles:

- Courses and topics of study are designed so that the student moves from the simple/basic aspects to the complex/more difficult aspects.
- The sequence of topics among nursing courses and between nursing and related science courses is planned to correlate as much as possible.
- Courses are structured to provide didactic instruction, skills laboratory and simulation exercises, small group discussions or projects, and direct clinical practice at a high level of correlation.
- Learning expectations are structured by program design and consistent use of theory and laboratory objectives.

Core Values of Odessa College Nursing Programs

- Core Value #1 Compassion: Provide holistic, patient-centered, evidence-based care to individuals and communities while recognizing and respecting the cultural factors that influence health, including age, religion, ethnicity, socioeconomic status, and gender.
- Core Value #2 Integrity: Ethical practice, professionalism, lifelong learning, and accountability while functioning within the legal scope of practice.
- Core Value #3 Innovation: Ethical use of informatics, technology, and data to support safe, effective nursing practices.
- Core Value #4 Advocacy: Demonstrate leadership, engagement in health policy, public health, equity, and regulatory awareness.
- Core Value #5 Collaboration: Effective communication and interprofessional teamwork with the healthcare team, patient and family to advance holistic care.
- Core Value #6 Excellence: Commitment to quality, safety, continuous improvement, and high standards of care.

Nursing Program Core Objectives

Given the rapid evolution of necessary knowledge and skills and the need to consider global, national, state, and local cultures, the core curriculum must ensure that students will develop the essential knowledge and skills they need to be successful in college, in a career, in their communities, and in life. Therefore, with the assistance of the Undergraduate Education Advisory Committee, the Coordinating Board has approved guidelines for a core curriculum for all undergraduate students in Texas.

The Odessa College faculty have evaluated all of their courses and have aligned them to Odessa College's Institutional Core Objectives as defined by the Texas Higher Education Coordinating Board (THECB).

Description and Alignment of Odessa College's Institutional Core Objectives (CO)

1. Critical Thinking Skills - to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information (All NURS, RNSG, VNSG)
2. Communication Skills - to include effective development, interpretation and expression of ideas through written, oral and visual communication (All NURS, RNSG, VNSG)
3. Empirical and Quantitative Skills - to include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions (All NURS, RNSG, VNSG)
4. Teamwork - to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal (All NURS, RNSG, except RNSG 2230, RNSG 2130)
5. Personal Responsibility - to include the ability to connect choices, actions and consequences to ethical decision-making (All NURS, RNSG, VNSG except VNSG1405)
6. Social Responsibility - to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities (All NURS, RNSG, VNSG except VNSG 1405)

Options/Tracks for the Nursing Student

The Nursing Programs at Odessa College have multiple options for students interested in pursuing a career in nursing. We offer prelicensure nursing programs that prepare students to assume beginning staff nurse positions under supervision as providers of care, coordinators of care, and members of the nursing profession. We also offer a post licensure program that prepares licensed nurses to build upon the foundational knowledge and skills acquired in the associate degree nursing program. Upon successful completion of the student's respective prelicensure nursing program track the student will be eligible to sit for the NCLEX-RN or NCLEX-PN.

RN to BSN Program Option:

The RN to BSN Program currently has one full-time program option. Courses are offered in a 12-month period. The entire didactic program curricula are online. However, the program has two clinical courses that require onsite clinical attendance in health facilities located in the Permian Basin of Texas.

Traditional Associate Degree Option:

The traditional track allows students the opportunity to take classes and receive clinical education during weekdays and some weekend hours. Students beginning their nursing career can apply for the traditional track, designed for students who do not hold any licensure to practice nursing as a Vocational Nurse. Odessa College admits students every fall and graduates them the subsequent fall semester. This cohort continues for 18 consecutive months, with courses occurring in the fall, spring and summer semesters.

Transition Associate Degree Option:

The transition tracks allow the student who has an active license to practice vocational nursing in the state of Texas to receive credit for selected courses through advanced placement. Transition courses are offered face to face at the Main Campus in Odessa and the Andrews campus in Andrews Texas, during weekdays and some weekend hours. The transition student receives advance placement credit for Foundations of Nursing Practice (RNSG 1513), Clinical Introduction (RNSG 1360), Common Concepts of Adult Health (RNSG 1441), and Clinical Registered Nursing/Common Concepts (RNSG 1261). Transition students are admitted twice a year, in the spring and summer semesters. The program continues for 1 year.

Traditional Licensed Vocational Option:

The traditional LVN track allows the students the opportunity to begin their nursing studies without the need for any pre-requisites. This track is offered at the Monahans and Andrews campuses. The program is designed for students with zero college experience or previous college course work to begin taking courses toward their nursing certificate. Any student can choose to begin with the LVN program and continue to the transition ADN track after receiving their LVN license. Traditional LVN students take classes for 1 year consecutively through all semesters. The traditional LVN program accepts students once a year to start each fall semester.

Extended Pathway Licensed Vocational Option (Part-Time):

The extended LVN track allows the students the opportunity to begin their nursing studies without the need for any pre-requisites. This track is offered at the Odessa Main campus. The program is designed for students with zero college experience or previous college course work to begin taking courses toward their nursing certificate. Any student can choose to begin with the LVN program and continue to the transition ADN track after receiving their LVN license. Traditional LVN students take classes for 18 months consecutively through all semesters. The traditional LVN program accepts students once a year to start each spring semester.

Dual Credit Licensed Vocational Option:

The dual credit track is offered at the Main Campus in Odessa, Odessa College Andrews, Odessa College Monahans, and Denver City High School. The dual credit tracks give juniors and seniors in high school the opportunity to complete 90% of the nursing curriculum while still in high school. This program is designed for the younger students that know nursing is where they want to be and desire to begin ahead of other students their age. The dual credit track begins the fall of the student's junior year and continues consecutively through the summer after High School graduation

Program Objectives

The Odessa College Nursing Programs prepare individuals to provide safe, competent, compassionate care to persons of need in the community. Upon successful program completion the Vocational or Registered Nurse will have demonstrated competency in the Differentiated Entry-Level Competencies according to *Program level of completion*. RN to BSN End of Program Outcomes

5. **Interprofessional Communication:** Utilize effective communication skills to advocate for evidence-based holistic care within the healthcare team.

Associate Degree Nursing End of Program Outcomes

1. Upon completion of the program, students will employ critical thinking skills by recognizing and analyzing data to prioritize, implement, and evaluate nursing care for improved client outcomes.
2. Upon completion of the program, students will demonstrate cognizance of cultural diversity, social responsibilities, and community service in nursing practice.
3. Upon completion of the program, students will demonstrate proficiency in technology to communicate, manage information, and make informed decisions in client care.
4. Upon completion of the program, students will demonstrate competency in providing, advocating, and collaborating for safe client-centered care within the healthcare environment.
5. Upon completion of the program, students will apply professional principles as a member of the healthcare team.

Vocational Nursing End of Program Outcomes

1. Upon completion of the program, students will be able to employ critical thinking skills in their identification of problems, collection and analysis of information and/or equipment, and conclusion.
2. To foster a sense of civic duty and empathy, preparing students to contribute positively to the well-being of communities while upholding the principles of ethical and socially responsible nursing practice the nursing program, students will demonstrate a commitment to social responsibility through active engagement in community service activities.

3. Graduates will demonstrate proficiency in employing diverse and culturally sensitive communication strategies in nursing practice. This includes the ability to convey information clearly and concisely, actively listen to patients and healthcare team members, adapt communication styles to diverse audiences, and effectively collaborate within interdisciplinary teams to optimize patient care outcomes.
4. Upon completion of this program, students will be able to demonstrate their proficiency in working within the scope of a Licensed Vocational Nurse exhibiting a thorough understanding of pertinent legal and ethical guidelines, competent patient care delivery, and adherence to professional standards.
5. Upon completion of the Licensed Vocational Nurse program, students will demonstrate the ability to be effective in clinical settings by competently performing nursing procedures, providing patient-centered care, with accuracy in documentation of care.

Advisement and Registration

The Odessa College Nursing Programs are competitive admission programs of study and follow a cohort model of instruction. The Nursing Department controls the registration and reserves places in each class for all nursing students throughout the program in a block scheduling format. Clinical courses cannot be audited. Nursing faculty also serve as additional academic advisors for students while in the nursing program. If degree plan issues arise, contact the Program Director. Should a student decide to enroll in additional courses outside of the nursing curriculum, they must schedule a time to meet with the program director prior to enrolling in courses. Nursing faculty also serve as additional academic advisors for students while in the nursing program. If degree plan issues arise, contact the Program Director.

Financial Aid and Scholarship

Odessa College is firmly committed to the philosophy of assisting students who do not have the financial resources to pay for higher education to attend college. The Student Financial Services Office administers four broad program areas: grants, employment, scholarships and loans. A Free Application for Federal Student Aid (FAFSA) and an institutional application are required for all need-based financial aid programs. If financial problems occur which potentially jeopardizes continuing in the Nursing Program, please seek guidance from your College Life Coach or Program Director.

Program Expenses and Student Responsibilities

All costs are the responsibility of the student with the exception of identified third-party support from ISD's (Dual Credit) and Employers. This support needs to be confirmed in advance of registration. This includes items such as tuition and fees for the nursing and non-nursing (general education) courses and required expenses from program application through National Testing. Note that books and supplies are REQUIRED. Many books are purchased prior to the first semester and are utilized during the entire program.

The RN to BSN program tuition will be equivalent to other bachelor's degree programs offered at Odessa College. Students in the RN to BSN program will be charged at the same rate per credit hour as it is in other associate programs.

Professional liability insurance is required each semester and is managed by the college. The cost of the insurance is included in the tuition and fees of each clinical course.

Health insurance must be purchased by the student and several sources are listed for the student on Odessa College main website Health Insurance for Students coverage lapses or is cancelled by the student at any time during the program students may be withheld from attending clinical with reciprocating grade/progression impacts.

Students are required to have current immunizations and screenings including the influenza vaccine, tuberculosis skin testing, and multiple urine drug screens. Clinical requirements are dictated by our clinical partners, and each facility is different. As we learn of new or changing clinical requirements, we will update students accordingly. Costs of clinical clearance vary from student to student, depending on their needs. Costs for screening, vaccinations, testing and drug screen fees are the responsibility of the students. Please see program secretaries for information on local screening resources.

Students are required to maintain current training in CPR and show proof of valid Healthcare Provider training through American Heart Association training at any time. Students may not take an *all-on-line* CPR course. Any CPR training that will expire during a term must be renewed prior to the beginning of term.

Transportation-related expenses are the responsibility of the student. Multiple clinical sites in the Permian Basin are utilized. Odessa College may not be held responsible for any accident, vehicular or otherwise, that occurs associated with student assignments.

Legal name and availability of personal contact information

All professional applications, including school and program applications, must be made using the student's legal name as validated by photo identification. The student's legal name will be submitted to the Board of Nursing and will be the name that is used for the student account with the Board of Nursing. Students must keep their most current address and phone number(s) on file. A routine update of pertinent student information will be made at the beginning of each semester.

FERPA

Students must sign a FERPA (Family Educational Rights and Privacy Act of 1974) release to approve the release of Confidential Records for Admission Purposes. To view the Odessa College Academic Privacy Statement follow this [link](#). Any records that are not available for review will not be considered as part of the admissions packet nor released by the College. Personal contact information will be kept confidential upon the student's request. Dual Credit students are also protected under

this act and the college asks that Parents of Minor Nursing Students work with their High School Counselors to understand their rights. Odessa College defines directory information per the document found [HERE](#).

Evaluation of faculty and courses

The Odessa College Nursing Programs welcome student feedback. Evaluations are most helpful when they are honest, fair, constructive, and pertinent to the class, clinical experience, or course. Faculty seriously considers student evaluations in making modifications in the course, specific classes, and clinical assignments. Evaluations of class, laboratory, and clinical teaching effectiveness are used by individual faculty in identifying areas of strength and areas for needed improvement. The faculty values student evaluation of teaching effectiveness as a means of improving teaching skills. Students are encouraged to evaluate classroom and clinical instruction using the forms and methods provided. In addition, verbal input is welcome. It is expected that our nursing students will fulfill this professional responsibility.

Grievance policy

It is recognized that most academic issues and concerns are resolved on an informal basis. In the nursing program we encourage and model the proper chain of command. The informal due process can be found below. Odessa College nursing will follow this process for all grievances. When an informal resolution is not possible, students may wish to employ a formal means to problem resolution. Information regarding the formal due process at Odessa College can be found in the [Student Handbook](#).

Informal Due Process:

If a student has a conflict with a faculty member or lab instructor relating to instructional matters or grading, the student should attempt resolution at the first level possible by conferencing with the following individuals in the order listed:

Informal resolution:

- ✦ Instructor
- ✦ Director of Nursing

Formal resolution

- ✦ Instructional Dean – at this level the Grievance Process becomes formal (Level 1)
- ✦ Vice President of Instruction (Level 2)
- ✦ President (Level 3)
- ✦ Board of Trustees (Level 4)

Grievance at clinical sites

Grievances at clinical sites between students and faculty will be as follows:

- Student to preceptor/mentor discussion followed by discussion with faculty
- If the issue is not resolved informally, students document the issue with full details. If the student is not comfortable discussing with the preceptor/mentor or if an informal discussion was unsuccessful, the **student should notify the faculty and clinical coordinator/program**

director immediately. The student will submit a grievance statement detailing the incident, attempts at resolution and desired outcome. The clinical coordinator or faculty will investigate and mediate to find a resolution. If a resolution is not found, the faculty will escalate the process to a formal grievance.

Civility Policy

In alignment with the Texas Nurses Practice Act and Student Accountability policy, the nursing programs are committed to maintaining a safe, inclusive, and respectful learning environment that promotes professionalism, collaboration, and academic success. Students are expected to demonstrate civility and professional behavior in all interactions within academic, clinical, and virtual settings. Incivility includes any behavior that disrupts the learning environment, compromises psychological or physical safety, or fails to uphold the standards of the nursing profession. Such behaviors may include, but are not limited to, bullying, intimidation, harassment, disrespectful communication, retaliation, or other conduct that interferes with teaching, learning, teamwork, or patient safety. Incidents of incivility will be addressed through the SOHS Code of Conduct policy and may result in sanctions up to and including dismissal from the nursing program.

Student mental health resources and support

Odessa College provides students the access to a multi-disciplinary Behavioral Intervention Team (BIT) to assist with student health and safety, and generally to assist persons in need. Students have access to Mental Health resources for free professional health counseling. Our student's mental health and wellbeing is a top priority for us in addition to the student's success in and outside of our classrooms. Student illness or injury

Illness denotes an unhealthy condition in which physical, emotional, or intellectual function is diminished or impaired.

Injury results from either internal or environmental factors. Injury may be biological, chemical, physiological or psychological in nature.

Infection control is a nursing responsibility. Students should begin the practice of protecting patients and visitors from all possible infections while in school. To do so, students should refrain from reporting to class or clinical if they are acutely ill (fever, acute GI disturbances, or other contagious disorders). The student is responsible for notifying the appropriate instructor for missed classroom or clinical time according to handbook and syllabi guidelines. The student is subject to being dismissed from clinical or lecture days if they arrive with symptoms suggestive of an infectious illness.

When a student receives an injury or becomes acutely ill at the clinical site, the instructor shall be notified. The nursing faculty will not assume responsibility for students in the clinical area who are excessively fatigued, emotionally unstable or labile, physically ill, or who exhibit behaviors indicative

drugs or alcohol use. The student will be dismissed from the clinical experience if any of these problems occur, and in the professional judgment of the instructor, the student is potentially unsafe to render nursing care.

Instructor Responsibility:

- A determination shall be made if the student needs an emergency room, employee health service, private physician or drug/alcohol referral.
- Notify the clinical team leader (course coordinator) and Clinical Coordinator/Program Director.

Student Responsibility:

- When a student is seen in the Emergency Room for care, they will notify their own insurance carrier. The student and the health insurance company will be billed for services rendered.

Returning to Class and/or Clinical following Illness or Injury:

- Students returning to class or clinical following an illness or injury may be required to obtain a release from the health care provider. If activity restrictions are prescribed, the health care provider's documentation must be explicit. It is the responsibility of the student to contact the instructor before the next class/clinical to see if a doctor's release is necessary. Failure to obtain the requested release will prohibit the student from entering the clinical or classroom setting until the doctor's release is obtained.

Students under the care of a healthcare provider

The health and well-being of the nursing student is paramount. Students who are under the care of a healthcare provider should discuss their nursing school status with their provider. You and your provider should discuss your risks for exposure and any needed or recommended precautions that you should take. You are also encouraged to discuss the physical expectations of clinical rotations. These expectations may include, but are not limited to: lifting, moving, and turning patients or equipment; standing for long periods of time; being active and on your feet for up to 12 hours during a clinical rotation. It is also recommended, although not required, to involve your nursing school faculty in the discussions surrounding any limitations and special advisement related to your health and wellbeing.

Any OC student under care of a healthcare provider MUST meet with the OC accommodations specialist. Students are responsible for obtaining appropriate documentation, such as that from a professional health care provider.

All students will sign an Exposure and Risk Waiver form at the beginning of their program.

Student-instructor communication

All instructors have scheduled office hours which are posted on-line and outside their office doors. Students are encouraged to contact their instructors if they wish to discuss their progress, a problem, or need other help related to their role as a student nurse. Contact the Program Director if further assistance is needed.

All official communications must take place through OC email and other faculty approved

communication platforms. See your course syllabus for more information. Students are to remember they are in an adult, professional program and will treat email and other communication as such, including all forms of communication, but certainly all forms of written communication, including text messaging. Each and every student will be expected to communicate with their instructor professionally and respectfully. Instructors reserve the right to address non-professionalism, lack of respect and or grammar issues within your email prior to responding to your email requests. A continued lack of adherence to professional communication via email, may result in additional assignments, per instructor or director.

Policies and procedures are communicated to students by means of the Student Handbook, course syllabi and learning materials packets. The handbook is revised as needed to provide current and accurate information to students in the Nursing Program.

Changes in policies and procedures will be announced to each class by the Program Director or faculty and copies of the revised policy will be distributed as handouts or on the departmental home page at the OC Web site. Instructors and/or the Program Director will answer student questions regarding stated changes.

Students and faculty are expected to maintain strictly professional relationships at all times. Faculty members are responsible for maintaining appropriate boundaries and avoiding relationships or interactions that may impair professional judgment, create a conflict of interest, or compromise the educational environment. Students who believe that a faculty member has violated professional boundaries or engaged in inappropriate conduct should promptly report their concerns to the Program Director, Dean of Health Sciences, or through established Odessa College reporting channels. Reports will be handled in a timely manner and in accordance with applicable college policies and procedures.

TEXAS BOARD OF NURSING POLICIES

Licensing criteria

The Texas Board of Nursing provides rules governing Vocational Nursing Education (Rule 214.1 – 214.13) and Professional Nursing Education (Rule 215.1 - 215.13) requiring that the dean/director and faculty are accountable for complying with the Board's rules and regulations and the Nursing Practice Act. Rules for professional nursing education programs shall provide reasonable and uniform standards based upon sound educational principles that allow the opportunity for flexibility, creativity, and innovation. It is your responsibility as a student nurse to be knowledgeable of the rules and regulations governing Nursing Education in Texas, including licensing and education requirements. Disciplinary sanction policies

Student accountability

The Texas Nursing Practice Act requires its practitioners to be fully accountable for their clinical

decisions and actions. Each nursing student is legally accountable to the level of her/his preparation and does not function under the licensure of a nurse. Accountability is the quality or state of being responsible and answerable for one's decisions, actions, and behaviors. Nurses committed to interpersonal caring hold themselves accountable for the well-being of clients entrusted to their care and are accountable to their clients, supervisors, and their colleagues. They are legally and ethically responsible for any failure to act in a safe and prudent manner. The Texas Nursing Practice Act gives nurses and student nurses the right to perform a broad range of dependent and independent functions. Enjoying this privilege means that they also assume legal and ethical responsibility for safe and effective performance at all times. Standards of practice have been developed by professional organizations which serve as guidelines in maintaining quality practice. For the Odessa College nursing student, accountability means that they will be, at all times, willing to learn and practice nursing with commitment and with personal integrity. It means being attentive and responsive to the needs of individual clients and colleagues. As the student acquires nursing knowledge and skills, they will assume professional responsibilities and develop competencies which will shape their attitude of caring. This attitude of caring and of being accountable develops as the student becomes sensitive to the ethical and legal implications of nursing practice. In nursing, we all share a common goal of providing the highest quality of care to individuals entrusted to our care. To successfully achieve this goal, the student should be dedicated to the following actions:

1. Participating in learning experiences and appropriately sharing these experiences and knowledge with instructors and classmates;
2. Upholding the philosophies and policies of the college, the nursing program, the clinical agencies within which the student practices, and the Board of Nurse Examiners for the State of Texas;
3. Maintaining the highest ideals, morals, personal integrity, and ethics possible; and
4. Making a commitment to being fully accountable, responsible, and answerable for their academic and clinical decisions, actions, and behaviors.

In being dedicated and committed to practicing the principles of accountability, the Odessa College Nursing Student can have the personal and professional satisfaction of knowing that they are doing everything possible to promote trustworthiness in both conduct and actions.

It is your responsibility as a student nurse to be knowledgeable of the laws and the rules and regulations governing nursing education programs and nursing practice. The following links are available for a thorough review:

NURSING STUDENT CONDUCT AND PERFORMANCE

SCHOOL OF HEALTH AND SCIENCES (SOHS) CODE OF CONDUCT

Admittance into a program in the SOHS at Odessa College is a highly selective and competitive process. The faculty and staff teaching in these programs expect students to demonstrate professional and ethical behavior at all times that are over and above student expectations as outlined in the Odessa College Student Code of Conduct. A Student Professional Incident form is used to alert you and to document behaviors that may result in a failing grade and hinder future selective admission processes resulting in permanent disqualification from any program in the SOHS. This is a notice to the student to become familiar with expected ethical and professional behaviors of your future profession. The School of Health and Sciences Code of Conduct in its entirety will be available on each course shell alongside the Student Handbook for your review.

HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT OF 1996 (HIPAA)

Consider all information obtained regarding the patient's status as strictly confidential, and not to be discussed with anyone except instructors and peers within the learning environment, and with authorized hospital personnel. (Learning experiences in the clinical area are to be shared during pre and post conferences and other related professional sessions).

All students are required to abide by HIPAA rules and regulations at all times. The following link contains needed information: <https://aspe.hhs.gov/report/health-insurance-portability-and-accountabilityact1996>

- Clinical sites may orient students to the agency's guidelines for HIPAA implementation.
- Patient names will NOT be posted on assignment sheets.
- Patient information must never be left visible to the public.
- Do not leave clinical paperwork in a place, even in one's own home, that is visible to others.
- When using computers in the clinical setting, or at home, never leave information on the screen for unauthorized people to gain access - log off.
- Faxes are to be placed in a secure area, face down.
- NEVER photocopy portions of the patient's chart, medication record, or lab/diagnostic findings.
- Even when the discussion concerning a patient is authorized, take care that it is not in a public area or where conversation could be overheard by others.
- A student may not answer the phone at any clinical facilities.
- Submit reports of patients to instructors using patient room numbers and birth date only, never the patient's full name.
- Remove the name of the patient if any information is obtained from the patient's chart and used away from the nursing unit.
- The use of social media to disclose, describe, depict, or otherwise share any portion of a clinical experience is strictly prohibited, regardless of whether patient identifiers are removed.

Student responsibility

- Consult with the instructor if the student feels that circumstances regarding the patient will hamper him or her from giving effective care or would potentially present sensitive issues regarding confidentiality (e.g., person known to the student).
- The student must conduct himself or herself in a professional manner when caring for patients or families and interacting with staff, instructors, and peers.
- Channel any concerns including criticism of an agency, an individual, or an instructor through the Director of the Nursing Programs. To instill confidence and trust in our program, students should refrain from critical discussion outside the school, on social media platforms, or with other students.
- Be honest at all times. A student who would cheat ultimately is cheating patients. A student who is less than completely honest in the clinical area jeopardizes patient safety and is subject to termination from the nursing program.
- Be responsible for one's own learning and help promote an atmosphere which facilitates maximum learning for his or her classmates. A student will not obstruct the learning process of others by causing undue anxiety for any reason, including monopolizing instructor's time.
- Be respectful of instructors and peers. Help maintain an atmosphere where you and others can learn and grow.
- Be responsible for reading and familiarizing self with printed college and nursing department policies and procedures, as well as policies and procedures in clinical agencies that impact the role and function of the student nurse.
- A student may not share one's own personal information with any patient in any clinical setting.
- Failure to abide by these regulations' present grounds for disciplinary actions up to and including dismissal from the nursing program.

Misrepresentation, Professional Integrity, and Ethical Conduct

Odessa College nursing students are expected to uphold the highest standards of honesty, integrity, and professionalism at all times. Any student who misrepresents their identity, credentials, role, title, level of training, clinical assignment, or status as an Odessa College School of Health Sciences nursing student, or who uses their affiliation with the nursing program to gain unauthorized access, privileges, or opportunities, will be subject to disciplinary action.

Examples of prohibited conduct include, but are not limited to:

- Falsely representing oneself as being assigned to a clinical site or participating in a clinical experience.
- Misrepresenting one's role, credentials, or authority to patients, visitors, healthcare

personnel, or members of the public.

- Using student status to gain unauthorized access to patient care areas, medical records, procedures, or restricted locations.
- Engaging in any dishonest, deceptive, fraudulent, or unethical conduct that reflects adversely on the nursing profession or the Odessa College School of Health Sciences.

*Violations of this policy may result in immediate dismissal from the nursing program. Students dismissed for violations of this policy will not be eligible for admission or readmission to any Odessa College School of Health Sciences program, will not receive a letter of good standing, and **may** be reported to the Texas Board of Nursing when the conduct constitutes a potential violation of professional or ethical standards. Such conduct may be evaluated in accordance with applicable provisions of the Texas Board of Nursing's disciplinary sanction policies regarding professional integrity, including behavior involving lying and falsification.*

Tobacco policy

Students are not permitted to use tobacco products at any health care facility including the immediate facility or their grounds; this includes cigarettes, cigars, e- cigarettes, and oral tobacco products. Violations will be subject to disciplinary action as enforced by the SOHS Code of Conduct.

ACADEMIC INTEGRITY

Academic integrity is important for the individual student and the program. Dishonest academic conduct in nursing education is inconsistent with the standards of professional nursing practice and may compromise patient safety. Violations of this policy may result in disciplinary action, up to and including dismissal from the nursing program. Scholastics dishonesty shall include but is not limited to, cheating on a test, plagiarism, use artificial intelligence platforms and collusion, or forging of any document used or turned in as a part of the nursing program. Examples are found below, but are not all encompassing:

- Copying from another student's test, quiz, or assignments.
- Using test materials not authorized by the person administering the test.
- Collaborating with or seeking aid from another student during a test without permission from the test administrator.
- Knowingly using, buying, selling, stealing or soliciting, in whole or in part, the contents of an administered test or assignment.

- Substituting for another student, or permitting another student to substitute for oneself, to take a test.
- Bribing another person to obtain an un-administered test or information about an un-administered test.
- Students are prohibited from making audio recordings, video recordings, photographs, screenshots, or other reproductions of remediation content.
- The nursing program acknowledges the unapproved use of artificial intelligence platforms to complete assignments as academic honesty.
- “Collusion” shall be defined as the unauthorized collaboration with another person in preparing written work for fulfillment of course requirements.
- Forging, in any capacity will not be tolerated. The assignment or document will not be accepted, and the student will receive a “Zero” for that assignment, a write up and possible dismissal from the nursing program.
- Plagiarism as defined below.

Students taking exams on campus, must adhere to the following rules:

- Leave personal items such as book bags and handbags in the nursing office or classroom. The secretary or instructor will secure the items so they are safe.
- Cell phones, watches and smart glasses are not allowed in the exam room.
- Do not talk to anyone who might come into the testing area.
- Should the testing area become noisy or in any way inhibits your ability to concentrate on the test, inform the test administrator.

ARTIFICIAL INTELLIGENCE (AI) POLICY

ANA Provision 4.2- Nursing practice authority can also be affected by technological advances such as the implementation and use of augmented intelligence or artificial intelligence (AI), especially when integrated without careful consideration of potential harmful consequences. To maintain nursing practice authority, nurses address barriers surrounding rapid and evolving technologies; lack of experience, exposure, and knowledge; poor representation by those in leadership roles; and unsupportive work environments.”

This policy outlines acceptable uses of Artificial Intelligence (AI) tools for students aiming to enhance their learning while upholding academic integrity. According to the American Nurses Association (ANA) 2025 Code of Ethics, Provision 4.1, “Nurses are accountable for fulfilling their ethical responsibilities. This includes choices to take or not to take action. Systems and technologies that assist in clinical practice are adjuncts to, not replacements for, the nurse’s knowledge and skill.”

The nursing faculty acknowledges that AI should not replace critical thinking skills, clinical judgment, or assessment skills. Instead, AI, including large language models like ChatGPT, Copilot, and Google Gemini, can supplement learning and writing processes when used ethically and sensibly. Students

should rely on their critical thinking skills, clinical knowledge, faculty feedback, and evidence-based practices to make clinical decisions rather than relying solely on AI recommendations, assignments, or writing papers. This policy applies to all nursing students at Odessa College and encompasses all educational settings, including classrooms, simulation hospitals, learning labs, online courses, online BSN students, and clinical environments.

Guidelines for AI Use

Students may use AI tools to:

- Reinforce concepts and improve understanding.
- Brainstorm ideas and strategies for answering an assignment prompt, such as asking for guidance on developing a thesis statement, organizing an essay, and using evidence to support claims.
- Find more information on the assignments.
- Check grammar and proofreading, but with caution. AI's spelling and grammar checking is not always accurate
- Students can use AI after they draft an outline of the assignment. This means the draft/outline should be the student's idea.
- Translating text from one language to another.
- Improving text to sound more "academic," and /or screening text for feedback and correction. However, students must ensure that synonyms AI suggested make sense within the context of their writing.
- AI tools that assist in literature searches are allowed; however, students must critically evaluate the sources and information provided by AI to ensure accuracy and relevance.
- Using it as a search engine like Google to find information and sources. But most publicly available AI aren't trained on the most current information (breaking news, etc.).

Inappropriate Use of AI

- AI should not be used for:
- Examinations/Tests/Quizzes
- Impersonating a student in classroom contexts, such as using an AI tool to compose a discussion board post.
- Writing an entire paper, PowerPoint presentation, sentences, and paragraphs, etc.
- Citing sources or incorporating sources into your writing. This is because AI can be wrong and often creates "hallucinations" that look correct but often don't exist.
- Writing a response to a prompt for you to copy and paste as your own without further reflection, editing, revision, or addition on your part.
- Writing a discussion post, journal, or essay for you.

How to Give Credit to AI:

- Students must give credit to AI tools whenever used, even if only to generate ideas.
- When using AI tools on assignments, add an appendix showing:
 - The entire exchange, including which AI tool was used highlighting the most relevant

sections

- o Explanations of how the AI tool was used (to generate ideas, provide an illustration, refine an idea, develop study tools, etc).

How to Cite AI in APA 7th Ed:

AI company Name. (year, month day). *Title of chat in italics* [Description, such as Generative AI chat].

Tool Name/Model. URL of the chat.

Plagiarism

Plagiarism is the act of presenting someone else's work, ideas, or words as one's own without proper acknowledgment. Plagiarism includes, but is not limited to:

- Copying text, ideas, images, or data from any source (including books, articles, websites, AI-generated content, or another student's work) without appropriate citation.
- Appropriating, buying, receiving as a gift, or obtaining by any means another's work and the unacknowledged submission or incorporation of it in one's own written work.
- Paraphrasing or summarizing another person's work without giving proper credit.
- Submitting an assignment that was written or completed, in whole or in part, by someone else.
- Using AI-generated content without proper attribution or in violation of course guidelines.
- Self-plagiarism involves reusing one's previous work for another assignment without explicit permission from the instructor.

Expectations for academic integrity

- Students are responsible for understanding and applying proper citation practices, including APA 7th edition formatting.
- All work (paper, discussion board, PowerPoint etc.) must be turned into **Safe Assign** in Blackboard-a plagiarism detection tool prior to submission.
- All work submitted must be original, with appropriate references for any external sources used.
- Students are encouraged to go the writing center for their paper to be reviewed by a tutor.
- If unsure about citation practices, students should seek clarification from instructors for guidance on citations and academic writing or utilize available academic resources.

Consequences of academic dishonesty

All cases will be evaluated on an individual basis. Sanctions will be determined in accordance with the SOHS Code of Conduct and may vary depending on the severity of the violation and the intent involved.

SOCIAL MEDIA /SOCIAL NETWORKING

Social media is any website or medium (including video) that allows for communication in the open. It includes but is not limited to e-mail, text messaging, instant messaging, blogs, podcasts, discussion forums, personal Web sites, "Wikis", video or picture sharing sites, interactive sites, and social networks.

A social network service is a communication portal, usually Internet-based, which provides a variety of ways, such as e-mail, text messaging and instant messaging, for users to interact with online communities or groups of people who share interests.

Guidelines:

1. Nursing students shall not use the name, trademark, logos, or copyright-protected material of Odessa College on any social media or social network service without permission of Odessa College.
2. Nursing students shall make it clear in any online activity that their views and opinions about school related matters are their own and are not the views of the Odessa College nursing program or faculty.
3. Nursing students shall not list their school e-mail address on any social networking site or any website unless the social networking site is used solely for Odessa College business or professional purposes.
4. A "private" social media site does not exist. Search engines can retrieve posts years after the publication date. Comments can be copied or forwarded. Archival systems save information even if the post was deleted. Nursing students are encouraged to think carefully about what they post and whether it reflects a professional demeanor. Nursing students should assume that the electronic communication may be circulated to important constituencies, such as their nursing instructors, hospital staff members, current employers, patients, and family members, and may result in punishment if the communication is deemed dangerous, unprofessional or out of alignment with the standards of conduct.
5. Nursing students shall not discuss any information in a forum which could be construed as Protected Health Information (PHI) under the Health Information Portability and Accountability Act (HIPAA). Protected Health Information is any information about health status, provision of health care, or location of health care. The use of social media to disclose, describe, depict, or otherwise share any portion of a clinical experience is strictly prohibited, regardless of whether patient identifiers are removed.
6. Nursing students are expected to respect the privacy of other nursing students and reframe

from posting photos, opinions, or other information which may portray the student or faculty member in a negative light.

7. Nursing students shall remain respectful of any clinical facility mission and strive to preserve the Odessa College Nursing Program professional reputation. Any nursing student that is dissatisfied with any aspect of Odessa College is encouraged to discuss those concerns with a nursing faculty member or the director of the nursing program. It is a violation of this policy to denigrate the quality of services at Odessa College in any social networking forum.
8. Social Networking with patients and or their family members is outside the therapeutic relationship and is considered a boundary violation and is prohibited.
9. Reporting: Nursing students and faculty have a duty to report nursing students who violate the social media/social networking policy. Any policy infractions and or abuse should be sent to the director of nursing.
10. Disciplinary actions:
Failure to follow this policy and its conditions may result in disciplinary action up to and including dismissal from the nursing program. If a nursing student's conduct on or off Odessa College campus adversely affects his or her performance as a student nurse, the performance of another student, or performance of a faculty member, the nursing student may be subject to disciplinary action as enforced by the SOHS Code of Conduct.

INCOMPLETE/ WITHDRAWAL POLICY

Grades of "I" (incomplete) may be issued when the student needs extra time to complete the theory or clinical course, due to an extenuating circumstance. The grade of "I" allows the instructor to work with a student who may be experiencing a family or personal crisis.

Program of Study BSN

The Bachelor of Science in nursing (BSN) at Odessa College is designed to lead the way in preparing nursing students for practice in a multicultural community within a diverse and changing health care environment; advance the practice of nursing; and provide quality, comprehensive health care in a competent, caring and compassionate manner. It is a post-licensure program (RN to BSN) designed for the registered nurse with an associate degree in nursing (ADN) from a regionally accredited institution of higher education that is accredited by a national nursing accrediting agency or a diploma in nursing from an institution that is accredited by a national nursing accrediting agency who wishes to earn a bachelor of science in nursing (BSN) degree. RN to BSN courses is offered in a 12-month period. The entire didactic program curriculum is online. However, the program has two clinical courses that require onsite clinical attendance in health facilities located in the Permian Basin of Texas.

The program student learning outcomes (PSLO) in the RN to BSN program: Students earning a Bachelor of Science in nursing degree will be able to:

- **Leadership Excellence:** Cultivate professionalism by demonstrating leadership qualities, fostering a commitment to ethical standards, and promoting a culture of excellence within healthcare organizations.
- **Compassionate Holistic Care:** Apply evidence-based compassionate care for individuals and communities, integrating leadership, and patient-family centered care approach in healthcare delivery.
- **Technology and Data Ethics:** Apply the use of healthcare information technology ethically, ensures safe practice and quality care to improved health outcomes.
- **Evidence Based Practices:** *Measure the impact of research and evidence-based practices for improved health outcomes.*
- **Interprofessional Communication:** Utilize effective communication skills to advocate for evidence-based holistic care within the healthcare team.

BSN Differentiated Essential Competencies of Graduates of Texas Nursing Programs (DECs)

The Odessa College RN to BSN program will ensure that graduates demonstrate progressive differentiation of competency levels, building upon the foundational knowledge and skills acquired in the associate degree nursing program. The content standards pertain to the understanding of nursing practice in areas such as leadership and management, evidenced based practice, community and public health nursing, information, and technology in healthcare, guaranteeing that students are adequately prepared to address the health needs of individual, community and public. The professional responsibility relates to preparing students to provide safe professional nursing care to individuals and community through the promotion of health, prevention of diseases, restoration of health and palliative and end of life care across lifespan.

Each course in the program has specific learning objectives that align with the DECs. These objectives would be clearly communicated to students and will serve as a guide for their learning

throughout the program. Also, clinical rotation and simulations (if needed) would be structured to provide opportunities for students to demonstrate proficiency in the DECs. Faculty, mentors and clinical instructors would provide feedback to students on their progress and areas for improvement related to the competencies.

The curriculum encompasses a comprehensive range of academic and professional nursing courses, which serve as the foundation for developing clinical proficiency and making well-informed decisions pertaining to healthcare scenarios and the provision of patient care across various clinical and community environments. Students in the post-licensure program will practice their nursing skills under professional supervision and coaching, through 30 semester credit hours and 48 clinical hours in the leadership & management plus community & public health course. Clinical skills emphasize the importance of nursing leadership and management, advocacy, community and public health. Students are expected to reflect, analyze and incorporate these skills at their workplace.

Furthermore, The BSN program emphasizes the importance of ongoing professional development to maintain and enhance competency in nursing practice. Students will be involved in opportunities to engage in continuing education with Odessa College partnered schools, certification programs, and professional organizations such as Sigma Theta Tau.

RESPONSIBILITIES OF STUDENTS IN THE ODESSA COLLEGE RN TO BSN PROGRAM AT CLINICAL SITES

RN to BSN Students Clinical Uniform Policy:

Students in the Odessa College RN to BSN program are allowed to wear any color of scrub. However, students must follow the guidelines above and the ones below at all clinical sites/ simulation laboratories:

- Students must always be dressed in their professional attire. Wear a white lab coat below the knee level on top of scrubs with student badge and patch. Students can wear any scrub and shoes of their choice.
- Students may wear short acrylic nails no longer than ¼ inch long.
- Students are expected to dress professionally including having all hair up.
- Each student will pick their mentor/s. Student can complete clinical hours at their primary place of employment. However, the mentor must sign a form and proof that shows the student is not at the workplace as RN. Students must handover mentor form and daily clinical evaluation form to mentor. All forms must be signed and submitted on Blackboard weekly.
- All students must abide by all Odessa College Nursing programs policies and clinical sites policies.

Students May:

Community & Public Health

- Attend meetings with nurse leaders or nurse administrators
- Conduct windshield survey
- Develop and present health education
- Assist in immunization clinics
- Assist at employee health clinics
- Participate in disaster preparedness training and planning
- Be a champion for rolling out protocols to improve patient's health outcome
- Participate in community outreach programs
- Participate in case management for patients with chronic illnesses
- Participate in quality improvement programs
- Help design and implement strategies to improve service delivery in community health clinics.

Leadership & Management

- Shadow nurse managers, directors or other healthcare leaders
- Attend leadership meetings
- Assist in identifying areas for quality improvement

- Participate in mock or real performance appraisals under supervision
- Collaborate on developing or revising policies to address healthcare strategies
- Observe how policies are implemented
- Facilitate or observe team-building activities
- Mentor junior nurses or nursing students
- Participate in interprofessional rounds and observe collaboration between healthcare teams
- Identify opportunities for improving team communication and patient outcomes
- Participate in planning and execution of departmental or organizational project

Student Responsibilities (Texas Board of Nursing Rule 3.7.3):

1. Coordinate personal schedule with the mentor's work schedule to avoid any conflicts.
2. Maintain open communications with the mentor and faculty.
3. Maintain accountability for own learning activities.
4. Prepare for each clinical experience as needed.
5. Be accountable for your own nursing actions while in the clinical setting.
6. Arrange for mentor's supervision when performing procedures, as appropriate.
7. Contact faculty by telephone, pager or email if faculty assistance is necessary.
8. Respect the confidential nature of all information obtained during the clinical experience.
9. Adhere to safety principles and legal standards in the performance of nursing care.

When students are assigned to non-nursing mentor such as epidemiologist, nutritionist, social worker etc, students are required to observe and shadow them ONLY in their specific roles and duties and adhere to the nursing student handbook.

Clinical Cellphone guidelines:

1. Nursing students shall follow all Nursing Student Handbook guidelines regarding the use of cell phones and electronic media in the clinical setting. (See Use of Electronic Communication Equipment policy)
2. Nursing students are not allowed to use computers or resources in the clinical setting to participate in social networking, or non-clinical related course work.

MENTOR'S GUIDELINES - BSN

The Odessa College RN to BSN program utilizes qualified mentors holding a master's degree or higher in nursing or other healthcare-related fields to enhance clinical learning experiences. Students in the RN to BSN Program must follow Texas Administrative Code Rule 215.10 and Texas Board of Nursing Education Guidelines 3.7.3 in selecting a preceptor or mentor. Preceptors/mentors are used in a nursing program after a student has received clinical and didactic instructions in all basic areas of nursing content. Nursing mentors must hold a current license to practice as a Registered Nurse or Advanced Practitioner in the state of Texas. The mentor must show evidence of teaching abilities, maintain current knowledge, clinical expertise and safety in the subject areas of teaching responsibilities. Also, mentor's philosophy must align with Odessa College Nursing Programs

A nursing mentor is a licensed nurse who has agreed to serve in this role either in a short term (one or two days) basis with **one or two students** or as a long-term (for the clinical rotation) mentor for no more than two students. While mentors may provide input on student performance, final evaluation and grading remain the sole responsibility of the nursing faculty.

Mentors must watch the recorded orientation video and sign the agreement form.

Non-Nursing Mentors

Non-nursing mentors must hold a master's degree or higher. When students are assigned to non-nursing mentors such as nutritionist, epidemiologist, health inspector, social worker etc. This clinical experience will be considered "observation clinical" which means students are not allowed to provide direct patient care; they can only observe. Students will sign a release form if they are to ride along with a health inspector for field observation.

OUTSIDE EMPLOYMENT

In the Leadership & Management (NURS 4457) course, RN to BSN students may complete their clinical hours at their place of employment. However, students cannot assume the dual role of employees and students simultaneously.

If completing clinical at your workplace, you are required to dress appropriately by wearing a white lab coat with the BSN patch and a visible name badge on the day of your clinical rotation. Clinical hours must be completed separately from your scheduled work hours. Students cannot function as an employee while completing clinical requirements.

Additionally, when engaged in outside employment activities, students are not permitted to wear any Odessa College identification.

EVALUATION AND GRADING POLICIES - BSN

CLASS/THEORY GRADING POLICY

The nursing programs grading scale for all NURS, RNSG and VNSG courses are different from that of the general college. A grade of "C" is awarded for numeric grades of 75%-79.99% in all nursing courses within the nursing programs. To be eligible for graduation and course completion, the Odessa College nursing student must have completed each of the prescribed courses in the curriculum with a minimum grade of "C".

90 – 100	A
80 – 89.99	B
75 – 79.99	C
74.99 – 0	D

Grades will be calculated at the end of the semester for each theory class according to the formula specified in the course syllabus after the student meets the exam threshold requirement.

There will be no rounding of grades in the Odessa College Nursing Programs. A grade of 74.99 (or lower) will prevent the student from continuing in the RN-BSN, ADN, and LVN programs. In the event of an absence, quizzes and daily work cannot be made up for a grade, but the assignment may still be required to fulfill course requirements. The student will receive a zero for those assignments.

Any course assignment the instructor assigns is designed to be a learning opportunity to develop critical thinking skills and help to develop an understanding of the course content. Students who choose not to complete an assignment given by the instructor will receive a zero for that assignment. In the event a student receives 3 unexcused zeros in a single course, a SOHS code of conduct violation will be issued to the student. Three SOHS code of conduct violations may result in Nursing Program dismissal.

If the student is absent on the day of an exam, they will be required to make that exam up on the first day of returning to class, and at a time that the instructor assigns. An automatic 10 points will be deducted from any exam that is not taken on the original assigned date and time. A make-up exam will be of the same testing content but may be a different format than the original exam.

Assignments, projects, discussion board, quizzes and papers must be turned in before the deadline. Please refer to the course schedule. No late work is accepted in the Nursing Programs. If there is an extenuating circumstance, the student should promptly notify the instructor prior to the due date of the assignment. The course instructor and program director will consider an exception on an individual basis. While late work is not accepted, and a zero will be received for the late assignment, the assignment is still required for course completion.

Any exceptions must be made and agreed upon in writing with the instructor of the nursing course before the exam time begins.

REMEDIATION POLICY

Students in the RN to BSN program may be required to complete remediation according to the following policy:

- A score of **74 or below** on a major assignment may be required to complete remediation. This promotes improvement in academic writing, APA formatting, and critical thinking. It provides an opportunity to earn up to 5 points back on the original assignment.

Remediation Requirements

- Submit a fully revised paper using APA 7th edition format, including:
 - Correct title page
 - Proper in-text citations
 - Accurate reference page
 - Clear organization, headings, grammar, and spelling
- Revise one weak rubric area by:
 - Expanding content with improved depth and accuracy
 - Addressing instructor feedback
 - Demonstrating critical thinking

- Incorporate at least one additional peer-reviewed source if required.
- Submit by the assigned deadline; late submissions require prior approval.

Grading

- Up to **5 points total** may be added to the original assignment:
 - APA corrections (2 points)
 - Evidence-based source integration (1 point)
 - Rubric revision quality (2 points)

Late Submission/Extension - (BSN ONLY)

Late Submission Penalties

- Assignments submitted within 24 hours after the deadline will incur a penalty of 10% off the total possible points for that assignment.
- Assignments submitted between 24 to 48 hours late will incur a penalty of 20% off the total possible points.
- Assignments submitted more than 48 hours late will not be accepted and will receive a grade of zero, except in cases where an extension has been granted prior to the deadline.

Extension Requests

- Extension requests must be submitted to the course instructor at least 48 hours before the assignment's due date. Requests must include a valid reason for the delay (e.g., medical emergencies, personal crises).
- Approval of extensions is at the discretion of the course instructor and will typically require supporting documentation (e.g., a doctor's note).
- Approved extensions will be granted a new submission deadline; no late penalties will be applied if the work is submitted by the extended deadline.

Exceptions

- Exceptional circumstances, which include severe illness, family emergencies, or significant personal hardships, will be considered for extensions without penalty. Appropriate documentation must be provided to support such claims.
- Students with disabilities who are registered with the university's Office for Student Accessibility Services may be granted specific accommodations regarding assignment deadlines, as outlined in their accommodation plans.

Responsibility of Students

- Students are responsible for planning their study schedules to complete assignments promptly.
- Students are expected to communicate with instructors about any potential delays as soon

as they are aware that a delay might occur.

- It is the student's responsibility to submit extension requests and supporting documentation in accordance with this policy.

Instructor Responsibilities

- Instructors are required to clearly communicate assignment deadlines at the start of the course and via the online learning platform.
- Instructors should provide timely feedback on received extension requests and maintain confidentiality and sensitivity regarding students' personal circumstances.
- Instructors will apply late penalties consistently and fairly in line with this policy.

CLINICAL GRADING POLICY

- Clinical courses are graded as Pass (PA) or Fail (F).
- Student performance is measured through assigned work and evaluations.
- A final (summative) evaluation is completed at the end of each course, with ongoing informal feedback provided by instructors and preceptors/mentors throughout the term.

Passing Requirements

- Students must achieve an overall average of 75% or higher across:
 - Assigned modules
 - Virtual simulations
 - In-person clinical hours
 - Daily clinical evaluation forms
 - Clinical reflective papers

Clinical Assignments

- A clinical reflective paper must be submitted within 48 hours of each in-person clinical experience.
- A daily clinical evaluation form must be completed by both the student and preceptor.
- Students are required to submit one reflective paper for each in-person clinical day.

Completion Expectations

- All required work must be completed at 100% of assigned requirements.
- Failure to complete all components as required may result in penalties or failure of the course.

Failing a clinical course will result in dismissal from the program

Clinical objectives and the clinical evaluation forms provide objective measures of the student's performance. While preceptors/mentors may provide input on student performance, final

evaluation and grading remain the sole responsibility of the nursing faculty. Instructor/preceptor/mentor observation of care delivered to clients, input from agency staff or preceptors/mentor, clinical assignments, written work, and other requirements are included in the assessment of clinical performance. Verbal and written feedback on student performance occurs throughout clinical courses (formative evaluation). A final evaluation occurs at the end of each course. Mid-point or rotational evaluations may occur to provide guidance and support to the students.

ADMISSION, PROGRESSION, READMISSION, DISMISSAL AND TRANSFER

ADMISSION AND ACCEPTANCE TO THE BSN PROGRAM

- Odessa College will honor Applied Associate in Science (AAS) in Nursing from other Community Colleges.
- Applicants must have at least a C in all previous nursing coursework.
- Applicants must have an overall GPA of 2.5 in all nursing coursework.
- Must have a minimum of 90 semester credit hours from pre-requisite courses + ADN courses prior to acceptance.
- Applicants must complete all prerequisite general education course work with a C or higher AND an overall GPA of 2.5 prior to starting the RN to BSN program.
- Applicants who have completed an Associate Degree in Nursing but have not yet taken the NCLEX at the time of application will be given **four weeks from the start of the program** to complete the exam.
- Applicants must have an unencumbered current Texas RN License OR RN License of the state currently residing.
- Must have a letter of recommendation from a previous nursing faculty member or a current employer.
- Applicants must be able to complete clinical hours in the state of Texas.
- Must be able to obtain clinical clearance from each clinical facility utilized.

PROGRESSION – BSN Program

If a **student fails a course in the RN to BSN program**, the student will wait until the next cohort when the course is offered to retake it. For example, a student taking a course in Spring 1 term that fails will wait until the course is offered in another cohort.

READMISSION- BSN Program

A re-admission applicant is defined as an individual who voluntarily withdrew or was dismissed from an Odessa College Nursing Program. **Re-admission is limited to one time.** Any exception to this policy must be requested in writing to the Program Director and the Dean for School of Health and Sciences.

Re-admission applicants are considered on an individual basis and based on clinical space

availability and at the discretion of the Program Director and the Dean for the School of Health Sciences during the appropriate admissions period. Any former student from the Odessa College Nursing Program desiring readmission must complete the following items that will be used in consideration of their re-admission application:

- Submit notification to the Program Director during the application period for program start, if planning to reenter at program beginning. If a student is requesting to enter the program at any point other than when the program starts, the Director should be notified at minimum 2 months (8 weeks) prior to requested entry.
- Meet the current admission requirements and procedures required of the respective nursing program applicants by the designated date/upcoming cohort.
- Submit a detailed, professionally written letter with their application to the Nursing Program Director stating:
 - The reasons for previous withdrawal or dismissal from the program
 - The reasons the student desires to be re-admitted.
 - The circumstances that have changed to indicate that the applicant would successfully complete their nursing education at this time.

TRANSFER POLICY FOR BSN Program

In addition to meeting all general admission criteria for Odessa College and the Odessa College Nursing Program; consideration of transfer students from another RN to BSN program and the assessment of transferable credits will be conducted individually and subject to the discretion of the Program Director. The following criteria must be met for consideration:

- Prospective transfer students must have earned a grade of “B” or higher in all nursing courses, which must have been completed within the past academic year at the previous institution. The curriculum of the student’s former institution must align with that of Odessa College nursing program.
- Transfer students are also required to meet the SACSCOC residency mandate, which stipulates that 25% of the degree program must be completed at Odessa College, equivalent to a minimum of 30 semester credit hours within the degree plan.
- Potential applicants seeking to transfer into the RN to BSN program at Odessa College are required to provide specific documentation a minimum of 4 weeks prior to the start of the upcoming semester for review. This includes:
 - Transcripts from all previous colleges/universities.
 - Detailed course syllabi containing course descriptions, clinical hours, evaluations, grades and any completed nursing coursework.
 - Letter of recommendation from the director of nursing program previously attended.
- Transfer students must complete at least 50% of the nursing program at Odessa College to graduate.

Notifications regarding the Program Director’s decision will be sent via email within 2 weeks of receiving all required materials.

COMMENCEMENT, PINNING, AND BSN MILESTONE CEREMONY

COMMENCEMENT

Odessa College has two commencement ceremonies a year: May and December. It is a requirement of the program that each Nursing student completes an application for their graduation ceremony. Vocational nursing students will submit an application for graduation for the May graduation ceremony. Questions about eligibility to participate in commencement should be addressed to the Office of the Registrar. The application for graduation must be completed by the deadline published in the catalog. The nursing department will assist graduates in completing the form if needed and provide the required degree plan.

REQUIREMENTS FOR GRADUATION

The nursing program's grading scale for nursing courses is different than that of the general college. To be eligible for graduation, the nursing student must have completed each of the prescribed courses in the curriculum with a minimum grade of "C". Each non-nursing course required for the degree must also be passed with a minimum grade of "C".

PINNING & BSN MILESTONE CEREMONY

Completion of an Odessa College Nursing Program is a time for celebration. As a program, our hope and goal are to offer a BSN milestone celebration that will be held for each graduating class separate from Odessa College's formal Commencement. When the college is unable to safely offer a BSN milestone ceremony, the Nursing Program will seek other avenues of celebrating and recognizing our graduates.

PRE-LICENSURE ADN & LVN



CORE OBJECTIVE COMMUNITY SERVICE PROJECT

All ADN and LVN nursing students are required to participate in community service activities totaling a minimum of 20 volunteer hours during their nursing program to be eligible for program completion. These service experiences support Odessa College Institutional Core Objective 6: Social Responsibility. All community service activities must receive prior approval from the nursing program before hours may be awarded. A maximum of eight (8) service hours may be earned from any single activity or organization. Community service participation is held to the same standards of professionalism and conduct expected in nursing classes and clinical settings. Inappropriate behavior, attitudes, or unprofessional conduct during volunteer activities will be addressed as a violation of the SOHS Code of Conduct.

PROFESSIONAL ATTIRE AND CONDUCT POLICY

Projecting a professional image is a responsibility and expectation of all nursing students. Appearance reflects not only on the individual but also upon the Odessa College Nursing Programs. The student dress code applies to students enrolled in all program tracks. Instructors enforce the dress code and will explain any exceptions to the dress code appropriate to the clinical requirements of the specific course.

General Professional Appearance and Behavior Policy:

The following guidelines are to be followed by all nursing students regardless of classroom, lab, simulation, or clinical locations:

- Students must always act professionally at all times. This includes profane and vulgar language in and outside of clinical, class, lab or simulation.
- Only natural hair color is permitted. No alternative (blue, purple, green, bright red, etc.), non- naturally occurring hair colors will be allowed.
- Nails are to be clean and short with rounded edges. No nail polish, acrylic, gel, or dipped nails are allowed.
- Personal hygiene must be maintained. Effective deodorant must be worn. Offensive breath should be avoided.
- Body art or tattoos should be tasteful or else covered up. Examples of body art that are not allowed include but are not limited to: tattoos that advocate gang representation, sexual, racial or religious discrimination. Any tattoo that is deemed inappropriate or not acceptable by an instructor, clinical instructor, preceptor/mentor or clinical site will be required to be covered for the duration of the program.

If you have questions about the appropriateness of attire or tattoo, make sure to receive approval from faculty or director as soon as possible.

STANDARDS FOR CLASSROOM CONDUCT

Students are expected to observe the following guidelines for classroom behavior:

- Under no circumstances are children, family or friends able to accompany you to class, the skills laboratory, or scheduled conferences with instructors. If this occurs, you will

be asked to leave.

- Children must not be left unattended in any area of the school building.
- You will need to talk with your instructor about your absence and any make-up required.
- Students are expected to be seated by the designated starting time for classes. If a student is not in the classroom by the designated start time and has not notified the nursing instructor of possible tardy, the door will be locked per OC policy and the student will be counted tardy and will be able to enter the classroom upon the first classroom break.
- Students will be required to come to class prepared. The requirements are per instructor discretion. If a student shows to class unprepared, they may be asked to leave the classroom to go prepare and they will be allowed back in upon instructor discretion.
- Students must request permission from the individual instructor of each course before using a tape recorder or other forms of recording in class. Permission is upon instructor discretion.
- If an instructor identifies a student who is behaving in an unacceptable manner in the classroom, simulation, or laboratory environment, the instructor will:
 - Inform the student of the nature of the unacceptable behavior and the student may be asked to leave the learning environment.
 - If the behavior continues a meeting may be scheduled with the Nursing Program Director, Dean, or Vice President for Student Services.
 - The interaction will be documented using the School of Health Sciences Code of Conduct and filed in the student's program record.

Areas that constitute unacceptable behavior include, but are not limited to:

- Interfering with the learning of others.
- Excessive tardiness.
- Intimidation of students or faculty.
- Inappropriate dress that is distracting to the learning process.
- Electronic devices disturbing others.
- Dishonesty.
- Any other behavior deemed by the instructors as unacceptable for the learning environment or as outlined in the SOHS Code of Conduct

Failure of the student to correct the deficiency and/or meet the stated objectives may result in failure of the course and could result in enforcement of the SOHS Student Code of Conduct.

ABSENCE AND TARDY POLICY - Classroom

Students are expected to attend all scheduled theory, laboratory, and clinical classes. Good attendance helps ensure success in nursing school as there is a large volume of materials to cover and laboratory/simulation/clinical experiences provide necessary connection of theory to practice.

Attendance and punctuality are professional responsibilities.

In the event of an illness or family crisis, the instructor should be notified as soon as possible.

Absences due to extenuating circumstances will be considered on an individual basis. Awarding of grades and progression are affected by absences in the following manner:

- Classroom instructors should be notified of any absence as soon as there is a conflict, a minimum of 15 minutes before the class begins. If the instructor cannot be reached, a message may be left on the instructor's voice mail or in the Nursing Office. Follow the guidelines set by each instructor, in their course syllabus.
- A tardy is considered an arrival of ≥ 1 minute after the start time of class as posted in the course syllabi or course documents.
- Failure to notify instructor of tardiness, greater than 15 minutes, or absence before the start time is considered a no call no show and will result in a SOHS Code of Conduct write up.
- If the student does not call, it will be considered a no call no show and the time must be made up hour for hour.
- A total of 3 tardies will automatically equal 1 full classroom day of absence. The hours will be counted towards that day's class(es).
- Students are not allowed to miss more than 10% of the course's contact hours, for any one course. Missing more than the allotted 10%, could result in dismissal from the Nursing Program.

Violations of any of these policies will result in an automatic grade of zero for a class/lab day and a written Violation of the School of Health Sciences Code of Conduct.

CLASSROOM/LAB ATTIRE POLICY:

Attire on campus should be appropriate for the setting.

- Suggestive or distracting clothing is not to be worn in the classroom setting or at any time the student is representing the program or college.
- No sleepwear is allowed.
- Nails are to be clean and short with rounded edges. Nails may not be visible over the tip of finger from palmer view. No nail polish may be worn. No acrylic, shellac or dipped nails may be worn.

USE OF ELECTRONIC COMMUNICATION EQUIPMENT - CLASSROOM

Students must be aware that the use of electronic communication devices are distracting to themselves and others. Students should give family members and others the phone number of the respective nursing office. See contact information within the student handbook. The nursing secretary will transfer messages of an emergency nature to students via the nursing faculty. All electronic communication equipment must be kept on silent and kept out of sight except as directed for educational activities by the faculty. Should students use electronic communication equipment during class time and it becomes a disruption to the faculty/instructor, student, or classmates, the student may be asked to leave the classroom. Unless a potential emergency exists, students must not leave the classroom to respond to a text or to make/receive cell phone calls. If

accommodation is needed, the student must inform the faculty/instructor prior to class start about the potential emergency.

Electronic devices, including but not limited to laptops, tablets, and smartwatches, may be used in the classroom for educational purposes when authorized by faculty. Students are expected to use electronic devices in a professional and responsible manner that supports learning and does not disrupt the educational environment.

Repeated violations of this policy are considered unprofessional conduct and will be subject to the SOHS Code of Conduct.

STANDARDS FOR CLINICAL CONDUCT

Odessa College nursing students are expected to uphold the principle of accountability by engaging in learning and nursing practice with dedication, professionalism, and unwavering personal integrity in all educational and clinical environments.

Clinical Guidelines:

- Student name badges and identification should be removed outside of the clinical setting. When feasible, students should not wear uniforms in public settings.
- Gum chewing is NOT permitted while in any lab, clinical area, or simulation setting.
- Students are not allowed to eat at the clinical site during clinical hours with the exception of the lunch period and scheduled breaks.
- Only disposable water bottles with lids are allowed in the clinical setting. No other packaging or drinks will be allowed to remain with the students during clinical time.
- Students are restricted from leaving the clinical facility for lunch or breaks, unless it is expressly indicated on the clinical schedule.
- Students are not to go to the parking lot or parking garage until the conclusion of the clinical day.
- Students must contact an Odessa College Nursing instructor for permission to leave the facility. Leaving the clinical site without approval given by an Odessa College nursing faculty will result in SOHS code of conduct violation and potential dismissal from the program.
- Students are allowed time off the unit for lunch ONLY. Students are not to be off the floor for more than what is stated below unless authorization is received from your clinical instructor (excluding sites that are closed for lunch).
- For 12-hour shifts students can take a 15-minute break in the morning and afternoon, with a 30-minute lunch.
- For 8-hour shifts students can take one (1) 15-minute break and a 30-minute lunch.
- All breaks and lunches should be communicated with your primary nurse or faculty member.

- Students are not allowed to have visitors to the clinical site at any time.
- Sleeping, resting with eyes closed, or resting with head on a desk is not permitted while at a clinical site. If you feel unwell, please communicate with your faculty members on site that day.
- Personal laptops, iPads, or any other form of electronic devices are not permitted at any clinical site.
- Nursing students are not allowed to use computers or resources in the clinical setting to participate in social networking, or non-clinical related coursework.
- Students are not permitted to work on non-clinical coursework while at a clinical site.
- Students being disrespectful to clinical instructors, hospital staff, patients, or other students (i.e. tone of voice, rolling eyes, body language, arguing with instructor/clinical staff) will be dismissed for the day.
- If a student is dismissed from a clinical site, for any reason, they are to leave the premises immediately (including parking lots). Leaving the site should be done in good taste and with respect of the program, the facility and yourself.

Any student that violates any clinical guidelines will be subject to the SOHS Code of Conduct.

Guidelines for Use of Nursing Laboratory and Simulation Spaces

All previously mentioned guidelines and appearance expectations will be enforced during simulation and laboratory experiences, in addition to the below guidelines. Clinical attire, guidelines and expectations are following while in simulation and laboratory unless stated by the faculty.

- The safety of students and patients is our priority. If a student is found to be in violation of discussed safety measures, the students will be subject to disciplinary actions to include but not limited to: code of conduct violation, additional learning activities or assignments, make up simulation or clinical time.
- Laundry is to be discarded in the laundry barrel. NEVER discard needles or trash in the laundry barrel. Use approved needle disposal units to discard needles and other sharp objects.
- Children are not allowed in this area.
- Keep off beds unless their use is part of practice in the lab. Before a student lies in the bed to serve as a patient, shoes should be removed.
- Straighten the bed after use. Replace chairs around tables. Leave the lab neat, clean, and orderly.
- No food or drink or gum is allowed in the lab.
- Use proper shut down procedure before turning off computers.
- The instructor and/or simulation lab coordinator will notify students of "Open Lab" times. The instructors and simulation lab coordinators will work with students to arrange

remediation, or evaluation of skill performance by appointment with approved faculty.

- Videotaped demonstrations and skills videos are available on Blackboard, ATI, and/or the streaming format of current textbooks. Nursing students must make time to view media prior to attending the scheduled skills lab if requested by the course instructor.
- Students who demonstrate deficiencies in the clinical setting may be sent back to the skills lab by the instructor for review and rechecks by nursing faculty /simulation lab coordinator.

Absence from Clinical and Simulation:

Attendance and punctuality are professional responsibilities. The following will result in an automatic grade of ZERO for a clinical day and may result in a written Violation of the School of Health Sciences Code of Conduct:

- Failure to notify the clinical instructor of a tardy at least 15 minutes before the clinical day begins.
- Failure to notify instructor of an absence before the start time, is considered a no call no show.
- A total of 3 tardies of less than 15 minutes late, per clinical course will automatically equal 1 full clinical day of absence and must be made up.
- Clinical absences: all will be made up to meet course objectives. Any tardy over 15 minutes from a clinical site will be considered an absence and must be made up.
- If a student shows up to a clinical without completed, proper paperwork, attire or equipment, the student will be sent home, and the clinical will be considered an absence and must be made up.
- Missed clinical hours must be made up to receive clinical course credit. There will be no partial credit given for clinical time. A full clinical day make-up is required regardless of the hours missed.
- A student in the nursing programs is allowed to miss clinical time that does not exceed two (2) days of clinical experience. For example: if your clinical course requires 12-hour clinical days, you are not allowed to miss more than 24 hours of clinical time. Any clinical time missed over the allowable, per clinical course, will result in a clinical course failure and possible dismissal from the program and will impact the student's progression through their degree or certificate plan.

CLINICAL UNIFORM POLICY AND CLINICAL/LAB GUIDELINES

Projecting a professional image is a responsibility and expectation of all nursing students. The student clinical dress code applies to students enrolled in all prelicensure program tracks and must be purchased prior to the beginning of any clinical rotations. *If you have questions about the appropriateness of attire, make sure to receive approval from faculty or director in advance of your*

clinical experience.

Clinical Uniform Policy:

Students who fail to comply with the clinical uniform policy will be dismissed from the clinical rotation and will not receive credit for the clinical day.

- The uniform consists of pewter gray scrubs. Uniforms may be purchased through the Odessa College Campus Store or other approved vendors.
- Uniforms must be clean, neat, pressed, and well fitting (not too tight or too loose). Student uniform appearing unkempt or dirty will be sent home from clinical, and will be subject to makeup time, or dismissal if overage of hours occurs because of clinical day absence.
- Uniform pants should be hemmed and not touch the floor.
- A white, gray or black undershirt may be worn under the scrub top.
- Undergarments may not be visible.
- A pewter gray scrub jacket is **required**. The scrub jacket may be purchased from the Odessa College Campus Store or other approved vendors.
- The Odessa College name tag must be worn on the left side of the uniform or lab coat. It must be visible at all times. Name Tags are purchased by the student as part of course fees and ordered by the Nursing Department. The student is responsible for any name tag replacements, including picking up and paying for the name tag at the local provider.
- Clinical agencies may require photo identification badges, and if so, the student must wear both the Odessa College student name tag and facility badge at all times when in the facility.
- Beards must be short and neatly trimmed.
- Hair must be clean, neatly groomed, and combed.
- A nice bun (no messy or loose buns) with no loose hair will be worn when in clinical. The hair may be braided and then made into a bun.
- Hair is not to touch the shoulders or collar of your attire.
- Hair must be pulled back and secured away from the face at all times. Students with short hair (male or female), must have hair pinned out of face, and should not hang below eyebrows. If hair touches the collar, then it will have to be pulled back. See your instructor for guidance.
- A solid black, gray, or white headband or scrub cap is allowed. No other hair décor may be worn.
- Makeup must be light and in good taste.
- Artificial eyelashes should be of natural length. See instructor for details.
- A single wedding band (gold, silver, or silicone) with no detail, or gemstones may be worn in the clinical setting.

- No other jewelry of any kind may be worn. This includes but is not limited to earrings, non-wedding bands or rings, necklaces and other visible body piercings or tongue rings. Small, clear or flesh-colored spacers are allowed.
- Religious medals and medallions will be discussed on a case-by-case basis. See Director for discussion.
- Nails are to be clean and short with rounded edges. Nails may not be visible over the tip of finger from palmar view. No nail polish may be worn. No acrylic, shellac or dipped nails may be worn.
- A white or black leather or plastic watch with a second hand will be required. (No smart watches are allowed.)
- Body art or tattoos should be tasteful or else covered up. Examples of body art that are not allowed include but are not limited to: tattoos that advocate gang representation, sexual, racial or religious discrimination. Any tattoo that is deemed inappropriate or not acceptable by a clinical instructor, preceptor or clinical site will be required to be covered for the duration of the clinical year.
- Footwear must be solid black or solid black with neutral-colored soles. The shoe must have a closed toe and have a closed heel/back (Example: tennis shoes or clogs for medical professionals). See instructor for further approval as needed.
- Students with special uniform needs pertaining to cultural or religious requirements should consult with the program director before purchasing uniforms.

If a clinical facility's dress code policy differs from OC nursing policy, the student at that clinical facility will be required to adhere to the additional regulations stipulated by the clinical facility. Instructors will explain clinical attire requirements within a specific course when these differ from the above requirements. (Examples: proper attire in community agencies, specialty areas in hospitals, hospital attire when not performing patient care, etc.)

SCOPE OF PRACTICE / CLINICAL CONDUCT

Students have the right by the Texas Nurse Practice Act to practice nursing as it relates to educational preparation. Standards of care must be the same as those rendered by a graduate nurse. Every person has a right to expect competent care even if provided by a student as part of their clinical training.

Noncompliance in any of the areas listed below may result in dismissal from the Nursing Program.

ALL ODESSA COLLEGE NURSING LVN and ADN STUDENTS MAY NOT:

- Leave the floor or unit without proper notification of preceptor and or instructor. Students will only be allowed off the floor or unit with their preceptor for clinical related activities. Students are permitted to leave their assigned location for their lunch time but must notify their clinical instructor/preceptor of their location when off the floor.

- Assume responsibility for patient belongings.
- Transport patient without supervision.
- Violate the tobacco policies of any clinical agency.
- Sign or witness patient or client signature for consents for any type of procedures, signature of an Against Medical Advice (AMA) form, or legal forms.
- Serve in an official capacity as a translator for patients or medical providers.
- Implement teaching plans or discharge plans without the primary nurse/preceptor or nursing instructor present.
- Fill out incident reports without a nursing instructor present.
- Take verbal or telephone orders from any physician.
- Perform post-mortem care without presence and permission of nursing instructor and/or preceptor.
- Scan, photograph, or record contents of patient documents.
- Have unauthorized patient contact.
- Use profanity or vulgarity while in the clinical setting.
- Violate HIPAA.
- Students may not possess patient medications without the direct supervision of the primary nurse, preceptor, or nursing instructor, nor place patient medications in their pockets at any time.
- Perform any skills that you have not been successfully checked off by an instructor.
- Perform any invasive nursing skills without the supervision of a licensed nurse.
- Administer any medication without the direct supervision of a licensed nurse.
- Eligibility to pass medications in clinicals will be revoked based on failure to satisfactorily complete current semester Medication Math Competency Exams.
- Perform vaginal examinations, vaginal checks or vaginal medication administration.
- Perform invasive procedures on pediatric patients (individuals younger than 18 years of age). Invasive procedures include, but are not limited to, newborn screening collection (previously known as PKUs), swabs, capillary blood glucose checks, injections, intravenous procedures, and urinary catheterization. Students may administer vaccinations to pediatric patients 10 years of age and older only with the approval and direct supervision of the primary nurse/preceptor or nursing instructor.
- Administer blood or blood products.
- Administer chemotherapy agents.
- Perform central line interventions other than site care and medication administration.

THE LICENSED VOCATIONAL NURSING STUDENT ADDITIONALLY MAY NOT PERFORM THE FOLLOWING:

- Perform any central line care. This includes flushes, dressing changes or medication

administration.

- Administer IV Push Medications, with the exception of saline flushes.

Use of Electronic Communication Equipment – Clinicals

Cell phone and electronic device use in clinical settings is limited to professional purposes and must not interfere with patient care, student learning, or the policies of the clinical agency. Any student that violates the following expectations will be sent home for the day and will be subject to the SOHS Code of Conduct.

Students are expected to adhere to the following requirements:

- Only cell phones and Odessa College-issued tablets are permitted in clinical settings. Personal tablets, laptops, smartwatches used for communication, and other electronic devices are prohibited unless specifically approved by faculty.
- Cell phones must remain on silent mode and out of sight while in any clinical setting, including nursing laboratories, simulation experiences, hospitals, and community agencies.
- Cell phones may be used only for professional or educational purposes and only in locations approved by faculty and/or the clinical preceptor/mentor.
- Personal calls, text messages, social media use, and other non-emergent personal communication are prohibited while in the clinical area of any healthcare facility or agency.
- Students experiencing a personal emergency must promptly notify the clinical instructor and may not leave the clinical area without appropriate notification and approval.
- If a student is suspected of inappropriate cell phone use in a patient care area, the student may be required to immediately present the device to the clinical faculty member or clinical preceptor/mentor for review.
- Students must not alter, delete, close, or otherwise modify any information on the device before presenting it for review.
- Refusal to present the device for review, or making changes to the device prior to review, will be considered a violation of this policy and may result in progressive disciplinary action as outlined in the SOHS Code of Conduct.

Students must comply with all electronic device policies established by the clinical site. If a clinical site's policy differs from Odessa College Nursing policies, the clinical site's policy will supersede Odessa College's policy.

Odessa College-Issued Tablet Usage

Odessa College-issued tablets are provided for educational purposes and the completion of required clinical documentation only. Students are responsible for the appropriate use of all college-issued technology.

- Odessa College-issued tablets may only be used to access the approved clinical charting application designated by the nursing program.
- Students are prohibited from accessing websites, applications, email accounts, social media platforms, messaging services, streaming services, or any other content unrelated to the

approved clinical charting application.

- Students may not log into personal accounts or any account other than the approved clinical charting application while using an Odessa College-issued tablet.
- Odessa College-issued tablets are subject to inspection by nursing faculty after each use to ensure compliance with this policy.
- Evidence of unauthorized applications, internet activity, account logins, downloads, or use unrelated to the approved clinical charting application will result in the student receiving a clinical absence for that day.
- A clinical absence issued as a result of inappropriate tablet use will be treated as if the student had not attended the clinical experience and will be subject to all attendance policies outlined in the nursing handbook.

SAFETY IN THE CLINICAL SETTING

Students are expected to provide appropriate care to all assigned patients during clinical learning experiences. These assignments may include clients with medical diagnoses of tuberculosis, hepatitis, AIDS, and other communicable diseases which pose potential risks to a care giver. The student is responsible for implementing standard precautions, transmission-based precautions, and adhering to all agency policies when providing care. The student should consult with the instructor, agency policies, and/or staff when questions of safety or infection control arise. Annual influenza vaccinations are a requirement for clinical during the influenza season. Proof of influenza immunization must be in the student chart at the nursing office. Any exemptions must be discussed with the nursing director. Students who are not vaccinated in accordance with clinical agency requirements may be required to complete additional health screenings or utilize personal protective equipment (PPE) as a condition of participating in clinical experiences. Any costs associated with required screenings, testing, or PPE are the responsibility of the student.

During times of pandemic or crisis, students will be required to follow Odessa College standards regarding clinical participation, as well as all clinical affiliate guidelines and standards. All students participating in clinical hours during such times, will be responsible for following personal protection equipment (PPE) requirements and self-monitoring for symptoms. Students will be required to follow instructor and director instructions regarding notification procedures for any type of exposure.

OUTSIDE EMPLOYMENT

Students may not serve the dual role of student and hospital/agency employee, including accessing facility resources as an employee, during the time the student is participating in a clinical laboratory experience. This may result in immediate dismissal from the program. Odessa College takes no responsibility for students who are employed while enrolled in the Nursing Program. The required student liability insurance purchased with payment of tuition and fees is valid in the student role and not the role of employee. When engaged in outside employment activities, the student will not wear any Odessa College identification.

CLASS REPRESENTATIVE EXPECTATIONS & AGREEMENT

Purpose

The Class Representative serves as the voice of their cohort, ensuring open communication between students and faculty. This position is vital in supporting a positive, respectful learning environment and representing the class at designated School of Nursing functions.

Responsibilities

- Attend faculty meetings as a student representative.
- Speak on behalf of the class regarding class-wide concerns, ideas, and feedback.
- Represent the class at official functions as requested by the School of Nursing.

Professional Expectations

- Maintain a minimum cumulative GPA of 2.0.
- Remain in good disciplinary standing, with no write-ups or formal warnings.
- Communicate professionally and respectfully with faculty, staff, and classmates.
- Demonstrate leadership, responsibility, and integrity.

Commitment

- Prioritize academic responsibilities to ensure my ability to fulfill this role.
- Notify faculty promptly if unable to meet the terms of this agreement.
- Serve as a positive example and a liaison between students and faculty.

Alternate Representative

An alternate representative will be selected and will assume the role if the original representative:

- Is unable to fulfill these responsibilities.
- GPA falls below requirement
- Receive a disciplinary action
- Requests to step down

EVALUATION AND GRADING POLICIES

CLASS/THEORY GRADING POLICY

The nursing programs grading scale for all RNSG and VNSG courses are different from that of the general college. A grade of “C” is awarded for numeric grades of 75%-79.99% in all nursing courses within the nursing programs. To be eligible for graduation and course completion, the Odessa College nursing student must have completed each of the prescribed courses in the curriculum with a minimum grade of “C”.

90 – 100	A
80 – 89.99	B
75 – 79.99	C
74.99 – 0	D

Grades will be calculated at the end of the semester for each theory class according to the formula specified in the course syllabus after the student meets the exam threshold requirement.

There will be no rounding of grades in the Odessa College Nursing Programs. A grade of 74.99 (or lower) will prevent the student from continuing in the ADN and LVN programs.

In the event of an absence, quizzes and daily work cannot be made up for a grade, but the assignment may still be required to fulfill course requirements. The student will receive a zero for those assignments.

Any course assignment the instructor assigns is designed to be a learning opportunity to develop critical thinking skills and help to develop an understanding and the course content. Students who choose not to complete an assignment given by the instructor will receive a zero for that assignment. In the event a student receives 3 unexcused zeros in a single course, a SOHS code of conduct violation will be issued to the student. Three SOHS code of conduct violations may result in Nursing Program dismissal.

If the student is absent on the day of an exam, they will be required to make that exam up on the first day of returning to class, and at a time that the instructor assigns. An automatic 10 points will be deducted from any exam that is not taken on the original assigned date and time. A make-up exam will be of the same testing content but may be a different format than the original exam.

Assignments, projects, discussion board, quizzes and papers must be turned in before the deadline. Please refer to the course schedule. No late work is accepted in the Nursing Programs. If there is an extenuating circumstance, the student should promptly notify the instructor prior to the due date of the assignment. The course instructor and program director will consider an exception on an individual basis. While late work is not accepted, and a zero will be received for the late assignment, the assignment is still required for course completion.

Any exceptions must be made and agreed upon in writing with the instructor of the nursing course before the exam time begins.

Exam Threshold Policy- ADN/LVN

Each theory course requires that students also reach an average of 75% on unit exams (50%) and the final (50%) in order to pass the course, this is called the EXAM THRESHOLD and no other grades will be utilized in determining the final grade until this threshold is met.

Below is an example of the calculation of the Exam threshold:

The student has taken 4/4-unit exams for the nursing course, scoring: 75, 82, 78, 88. These scores are averaged at: 80.75. The student takes the final exam and scores a 68. The final (68) and the unit exam average (80) are added together (148) and divided by 2 (74). The student here would not meet the exam threshold requirement of a 75, and in turn would not receive credit and would receive a "D".

In addition, each candidate for graduation must meet all other course and program requirements, pay for all NCLEX-RN or NCLEX-PN examination fees, complete the Texas Board of Nursing (TBON) jurisprudence exam, satisfy all college financial obligations, complete certificate confirmation in the Odessa College's Record's Office by the specified deadline, and return any and all school property to meet the graduation requirement.

Additional Information for ADN ONLY:

The ADN program has implemented midterm exams in specific theory courses. For the courses that have a midterm, the exam threshold is calculated as outlined below.

Each theory course with a midterm requires that students also reach an average of 75% for the exam threshold. The exam threshold is calculated by averaging: 1) the average of all unit exams, 2) mid-term exam score, and 3) final exam score. No other grades will be utilized in determining the final course grade until this threshold is met.

Below is an example of the calculation of the Exam threshold:

The student has taken 4 weekly unit exams for the nursing course, scoring: 75, 82, 78, 88. These scores are averaged at: 80.75. The student takes the mid-term exam and scores a 70 and takes the final exam and scores a 74.

The weekly exam average, mid-term exam and final exam are added together ($80.75 + 70 + 74 = 224.75$) and divided by 3 ($224.75 / 3 = 74.9$). The exam threshold would be a 74.9.

The student here would not meet the exam threshold requirement of a 75, and in turn would not receive credit and would receive a "D".

Grades will be calculated at the end of the semester for each theory class according to the formula specified in the course syllabus. There will be no rounding of grades in the Odessa College Nursing Programs. A grade of 74.99 (or lower) will prevent the student from continuing in the RNSG or VNSG program.

REMEDATION POLICY

All students in the nursing programs will be required to complete remediation according to the following policy:

- Any unit examination with a score of 75 or lower will require the student to schedule a remediation appointment with their instructor before the next unit exam. Instructors may require a higher score for mandatory remediation (i.e., 80 or below). The same policy will apply if the instructor requires a different cutoff score to remediate.
- Students may be asked to show proof of exam preparation during the remediation appointment.
- Remediation may differ from course to course or instructor to instructor and may include but is not limited to: exam review, reflective analysis, additional ATI or exam question practice, and additional tutoring.
- Remediation scheduling and completion is the responsibility of the student.
- Failure to schedule, and complete remediation prior to your next exam will disqualify you from taking your next exam at the scheduled time. Students are not allowed to take the

next exam until remediation has occurred. If a student is delayed in completing required remediation in order to be able to take their next exam, they will receive a 10 points deduction for a late test on the next exam.

CLINICAL GRADING POLICY – ADN/LVN

Clinical course grades are Pass (PA) or Fail (F). Clinical objectives, care plans, concept maps, daily assignments, and evaluations provide the objective measure of the student's performance. A summative or final evaluation occurs at the end of each course, informal evaluation and feedback occurs consistently throughout the clinical course by instructors and preceptors.

To pass a clinical course, students must obtain an average of at least 75% or above on the total number of care plans, concept maps, and objectives assigned in each clinical course along with daily grades. The total number of care plans or concept maps assigned in each course must be submitted to the instructor in order to pass each clinical course.

- Care plans, concept maps, and/or objectives will be assigned within each clinical course and are required to be submitted in the order that the course instructor assigns.
- No late work for care plans, concept maps, daily assignments, or objectives will be taken. If there is an extenuating circumstance, the student should promptly notify the instructor prior to the due date of the assignment. The course instructor and program director will consider an exception on an individual basis. Failure to submit clinical assignments by the due date will result in an unexcused clinical absence.
- Work must be completed at 100% or it will not be accepted. Incomplete or insufficient clinical work will be considered failure to meet the clinical objectives and will result in an unexcused clinical absence for that day.
- Care plans, concept maps, and objectives will be graded on the rubric designated within each assignment.
- Clinical daily grades will be based on student performance, preparedness and engagement.

Failing a clinical course will result in dismissal from the program.

Clinical objectives and the clinical evaluation forms provide objective measures of the student's performance. While preceptors/mentors may provide input on student performance, final evaluation and grading remain the sole responsibility of the nursing faculty.

Instructor/preceptor/mentor observation of care delivered to clients, input from agency staff or preceptors/mentor, clinical assignments, simulation assignments, charting, assigned written work, and other requirements are included in the assessment of clinical performance. Verbal and written feedback on student performance occurs throughout clinical courses (formative evaluation). A final evaluation occurs at the end of each course. Mid-point or rotational evaluations may occur to provide guidance and support to the students.

ADMISSION, PROGRESSION, READMISSION, DISMISSAL AND TRANSFER – ADN/LVN

Disclosure: Dismissal from any Odessa College health sciences program may disqualify an applicant from admission to any Odessa College nursing program. Determinations regarding eligibility for admission will be made at the discretion of the Nursing Program Director.

ADMISSION AND ACCEPTANCE TO THE ADN PROGRAM

- Applicants must have an overall GPA of 2.5 overall GPA.
- Applicants must complete all prerequisite course work with a C or higher.

ADMISSION AND ACCEPTANCE TO THE ADN PROGRAM

- Applicants must have an overall GPA of 2.5 overall GPA.

PROGRESSION – ADN/LVN

- Students will abide by the current Nursing admission, curriculum and program requirements at the time they are admitted or readmitted into the program.
- Nursing courses are sequential. Special progression is allowable only with approval of the Program Director and Dean of the School of Health Sciences.
- Progression in the nursing program is dependent on achieving grades of higher than a “C” in all required courses in the Plan of Study for the appropriate academic year of admission.
- To receive a grade of “C”, a minimum grade of 75% must be attained in each nursing course (*See Evaluation and Grading Policy*).
- Once enrolled in the Nursing program, a student who receives a D, or W in a nursing course, or withdraws from a nursing course must follow the re-admission guidelines before enrolling in a subsequent nursing course.
- Once enrolled in the nursing program, it is expected that enrollment is continuous. Students with a break in enrollment must apply for readmission. A break in enrollment includes, but not limited to:
 - Receipt of a grade of D or W in a nursing course requiring a repeat of the course
 - Withdrawal from a nursing course or subsequent failure of a co-requisite course
 - Non-enrollment in a nursing course for one or more semesters

REASONS FOR DISMISSAL FROM THE NURSING PROGRAM

A student may be dismissed from a Nursing Program for demonstration of unprofessional and unsafe behaviors as described in the [Texas Administrative Code 213.27](#) and the [Texas Board of](#)

[Nursing Rules and Regulations](#) sections 214.8 and 215.8.

Evidence of actual or potential harm to patients, clients, or the public. Criminal behavior whether violent or non-violent, directed against persons, property or public order and decency. Intemperate use, abuse of drugs or alcohol, or diagnosis of or treatment for chemical dependency, mental illness, or diminished mental capacity.

Lack of good professional character as evidenced by a single incident or an integrated pattern of personal, academic and/or occupational behaviors which, in the judgment of the Board, indicates that an individual is unable to consistently conform his or her conduct to the requirements of the Nursing Practice Act, the TBON's Rules and Regulations, and generally accepted standard of nursing practice including, but not limited to, behaviors indicating honesty, accountability, trustworthiness, reliability, and integrity.

Violating nursing student handbook policies and expectations will lead to repeated write-ups and consultations. Repeated behavior and write-ups will lead to a dismissal from the nursing program. Course failures, failure to be cleared for clinical rotations, and SOHS Code of Conduct write-ups will result in a dismissal from the nursing program.

The following are examples that will result in a course failure, clinical clearance failure and or SOHS Code of Conduct violation.

- Any time missed over 2 full clinical days one clinical semester
- A clinical make-up day is missed or the student is sent home will result in clinical course failure
- Leaving a clinical site without appropriate approval from faculty
- Performing nursing skills, procedures, or duties beyond the scope of practice outlined by the student handbook
- Two (2) no call/no shows in the program
- Any theory course absence of more than 10% of scheduled class time
- Any overall course grade below 75%
- Any course exam threshold average of below 75%
- Not meeting the math competence thresholds each semester
- Having 3 SOHS Code of Conduct write-ups during the Associate Degree program or Vocational Nursing program duration
- Not meeting clinical clearance requirements.
- Refusing to submit to a drug screen, or failure to pass a drug screen.

READMISSION- ADN/LVN

A re-admission applicant is defined as an individual who voluntarily withdrew or was dismissed from an Odessa College Nursing Program. Re-admission is limited to one time. Any exception to this policy must be requested in writing to the Program Director and the Dean for School of Health and Sciences.

Re-admission applicants are considered on an individual basis and based on clinical space availability and at the discretion of the Program Director and the Dean for the School of Health

Sciences during the appropriate admissions period. Any former student from the Odessa College Nursing Program desiring readmission must complete the following items that will be used in consideration of their re-admission application:

- Submit notification to the Program Director during the application period for program start, if planning to reenter at program beginning. If a student is requesting to enter the program at any point other than when the program starts, the Director should be notified at minimum 2 months (8 weeks) prior to requested entry.
- Meet the current admission requirements and procedures required of the respective nursing program applicants by the designated date/upcoming cohort.
- Submit a detailed, professionally written letter with their application to the Nursing Program Director stating:
 - The reasons for previous withdrawal or dismissal from the program
 - The reasons the student desires to be re-admitted.
 - The circumstances that have changed to indicate that the applicant would successfully complete their nursing education at this time.
- Students who have been out of the nursing program for less than one (1) year may be permitted to demonstrate competency in previously passed introductory nursing courses through a testing process, at the discretion of the Program Director. The option to test out of coursework is limited to introductory-level courses only and does not apply to advanced nursing courses or clinical courses.
 - Competency is demonstrated by taking final exams for all pre-requisites or previously completed courses, and passing with a minimum of an 80.
 - Math threshold exams must be passed with minimum threshold for the corresponding course or at the level of student re-entry. If student is re-entering at semester 2, semester 1 math threshold must be passed at the required score.
 - Skills competencies must be demonstrated for each semester for the corresponding course or at the level of student re-entry.
- Students who have been out of the program more than a year, or the course content is more than 1 year ago are not allowed to test out of previously passed course work and will be required to begin the program from the beginning of the nursing program.
- Following a second (2nd) withdrawal from the program, a student may petition for re-admission when a withdrawal occurs because of a catastrophic event. The student must have had a passing grade in the RNSG or VNSG course at the time of withdrawal.

The department reserves the right to deny readmission to a student who has violated the School of Health Sciences Code of Conduct. Students who are unsuccessful in a professional nursing program and subsequently complete a vocational nursing program are eligible to apply to the LVN-ADN Transition Program. Eligibility penalties for the “D’s, F’s or W’s” earned in nursing courses while previously enrolled in the professional nursing program are eliminated for these students.

INELIGIBILITY FOR READMISSION

Students are permitted a maximum of **one (1) readmission attempt** into an Odessa College nursing program. Students who are unsuccessful following readmission will not be eligible for additional readmission.

Students are not eligible for readmission into any Odessa College nursing program under the following conditions:

- Fail or withdrawn from the program twice.
- Dismissal from any Odessa College nursing program due to a violation of the School of Health Sciences (SOHS) Code of Conduct.

TRANSFER POLICY

For ADN and VN Programs: In addition to meeting all general admission criteria for Odessa College and the Odessa College Nursing Program, students seeking transfer admission to the Odessa College Nursing Program are required to meet the following criteria:

- Potential applicants seeking to transfer are required to provide specific documentation a minimum of 4 weeks prior to the start of the upcoming semester for review. This includes:
 - Transcripts from all previous colleges/universities.
 - Detailed course syllabi containing course descriptions, clinical hours, evaluations, grades and any completed nursing coursework.
 - A letter of recommendation from the director of the applicant's previously attended nursing program must be submitted directly to the Nursing Program Director.
- Students who have not been active in any nursing program for more than one long semester will not be admitted as a transfer student but can be considered for admission as a beginning nursing student.
- Students who have been out of the nursing program for less than one (1) semester may be permitted to demonstrate competency in previously passed introductory nursing courses through a testing process, at the discretion of the Program Director. The option to test out of coursework is limited to introductory-level courses only and does not apply to advanced nursing courses or clinical courses.
 - Competency is demonstrated by taking final exams for all pre-requisites or previously completed courses, and passing with a minimum of an 80.
 - Math threshold exams must be passed with minimum threshold for the corresponding course or at the level of student re-entry. If student is re-entering at semester 2, semester 1 math threshold must be passed at the required score.
 - Skills competencies must be demonstrated for each semester for the corresponding course or at the level of student re-entry. Skills must be passed on the first attempt with a grade of "Pass". Skills will be graded using the guidelines for the semester skills being tested. Practice sessions may be scheduled by the student with the Odessa College nursing instructors.
- All transfer students' point of reentry will be determined on a case-by-case basis after

reviewing transcripts, grades, meeting all admission requirements, and discussion with the student

- Submit a detailed, professionally written letter with their application to the Nursing Program Director stating:
 - The reasons for previous withdrawal or dismissal from the program
 - The reasons the student desires to be re-admitted.
 - The circumstances that have changed to indicate that the applicant would successfully complete their nursing education at this time.
- Attend a conference with the program director.

Transfer of Credit

Students with course credits from other accredited colleges or universities must provide the registrar with an official transcript. The registrar's office evaluates general education transfer credits. The program director will review course credits and decide transferability when the student requests course substitution for those courses required on the degree plan. Transfer of nursing credit occurs only when course content is deemed equivalent with that of Odessa College.

ATI: ASSESSMENT TECHNOLOGIES INSTITUTE

ATI TESTING AND REMEDIATION

Students enrolled in courses with an ATI proctored examination component will be assigned two ATI practice assessments (Practice A and Practice B) during the course. These assessments are designed to evaluate student understanding of course content and prepare students for the proctored examination.

ATI remediation tools, enrichment activities, and intervention strategies are intended to support student success and address identified learning needs. Students are required to complete individualized ATI remediation, including associated quizzes, for each ATI Practice A, Practice B, and proctored examination, in addition to any enrichment hours or assignments required by faculty. Specific expectations and deadlines will be communicated by the instructor of record and outlined in the course calendar.

ATI proctored examinations are secure, online assessments scheduled and administered by nursing faculty. Completion of all assigned ATI components, enrichment activities, and remediation requirements by the established deadlines is a course and program requirement.

To receive remediation points, all assigned components must be completed in their entirety and submitted by the designated deadlines. Remediation is graded on an all-or-nothing basis. Students who fail to complete any required ATI practice assessment remediation or proctored examination remediation by the deadline will forfeit the 15 remediation points and will receive the base examination grade. No exceptions will be made.

ATI GRADING RUBRIC

The following rubric is utilized by all RNSG and VNSG courses with an ATI exam component.

- The first column represents the raw grade that is awarded per the ATI Level achieved by the student.
- The second column represents the points for remediation that will be added to the raw ATI score.
- The third column represents the total points that will be awarded for students who have completed ALL the remediation requirements. This score is the score that will be used as part of the overall course grade calculation (i.e., 10%).

Comprehensive Predictor Exam Grading:

The Comprehensive Predictor Exam results include a raw score and a Probability of Passing (PoP) percentage. Students will receive the PoP percentage on the first attempt as their ATI grade in the course that it is aligned with (see tables below). Students will forfeit 15 points from the PoP score if they fail to complete any portion of the student success plans as outlined above.

ATI END OF PROGRAM PROCEDURES

ATI Live Review

Given to all RNSG students and the Traditional LVN students

An ATI live review course will be held at Odessa College. The ATI live review will be scheduled for the last semester of the program. All students will take the ATI Comprehensive Predictor after the ATI Live Review is completed. Attendance is required for 8 hours a day for the three (3) days of the review. Any hours missed will be approved in advance of the review per the Director and will require additional NLCEX prep work on the part of the student including but not limited to completing 500 NCLEX prep questions for each 1 hour of the live review missed or being required to attend additional enrichment hours.

ATI Virtual Review (VATI)

- VATI is implemented to help support the student's individual needs at the end of the program, further supplementing the student success plan to prepare students for success on NCLEX. VATI is given to all RNSG students and the LVN Dual Credit students.
- The course will begin at the earliest, 8 weeks before graduation. Attendance is required in the classroom until completion of VATI coursework. The student will be responsible for communicating with the ATI coach and completing the assignments/modules by the deadlines provided by the VATI contract.
- All students are required to take the comprehensive predictor exam administered by the faculty.

ATI FEES

ATI fees are collected as course fees attached to nursing courses throughout the program. Total ATI Fees are subject to change at any time, each student is responsible for the ATI fees.

MEDICATION MATH COMPETENCY

Calculating correct dosages, IV rates, and other medications is essential to safe practice in nursing. Since math medication errors greatly endanger patients, it is required that each student must demonstrate proficiency in medication calculation competency prior to program completion. The ability to accurately calculate medication dosages will be measured in the following ways:

- Dosages will be accurately calculated in the skills laboratory, simulation, and clinical setting.
- Medication calculation questions are included on exams in nursing courses at the instructor's discretion.
- General Instructions:
 - Students must show all calculations. Scratch paper will be furnished and must be submitted with the completed test.
 - If retesting is required, the student is responsible for making the arrangements for remediation.
 - Testing deadlines will be enforced.
 - Nursing Students will complete the Med Math Competency Threshold according to the

table below:

- Any student who scores below the required scores on the Med Math attempts are required to complete remediation or participate in tutoring before the next med math attempt.
 - Eligibility to pass medications in clinicals will be revoked based on failure to satisfactorily complete current semester Medication Math Competency Exams.
- Any student who is not successful at achieving the minimum competency score by the end of the 3rd attempt will be dismissed from the nursing program and will be eligible for readmission the following year or course offering pending pursuant to readmission policies.

COMMENCEMENT AND PINNING

COMMENCEMENT

Odessa College has two commencement ceremonies a year: May and December. It is a requirement of the program that each Nursing student complete an application for their graduation ceremony.

Vocational nursing students will submit application for graduation for the May graduation ceremony. Questions about eligibility to participate in commencement should be addressed to the Office of the Registrar. The application for graduation must be completed by the deadline published in the catalog. The nursing department will assist graduates to complete the form and provide the required degree plan.

REQUIREMENTS FOR GRADUATION

The nursing program's grading scale for nursing courses is different than that of the general college. To be eligible for graduation, the nursing student must have completed each of the prescribed courses in the curriculum with a minimum grade of "C". Each non-nursing course required for the degree must also be passed with a minimum grade of "C".

PINNING CEREMONY

Completion of an Odessa College Nursing Program is a time for celebration. As a program, we offer a pinning ceremony that would be held for each graduating class separate from Odessa College's formal Commencement. When the college is unable to safely offer a traditional pinning ceremonies, the Nursing Program will seek other avenues of celebrating and recognizing our graduates. During the pinning ceremony, each graduate is given a lamp and a pin to signify their welcoming into the nursing profession.

Student awards presented at pinning:

- Nightingale Award – peer award to the student who represents nursing at its finest.
- Academic Excellence Award – presented to the highest-ranking student(s) ranked

by GPA in core nursing courses.

- Clinical Excellence Award – presented to the student voted by faculty for outstanding clinical performance.
- Asset to the Profession- presented to the student voted by faculty for being an asset to nursing.

HEALTH AND SAFETY REQUIREMENTS FOR SCHOOL OF HEALTH SCIENCES STUDENTS

POLICY AND RELEASE OF INFORMATION

Student admitted to Odessa College Nursing and School of Health Sciences programs must submit to a criminal background check two to three months before the first semester of the program's curriculum. The student understands that the background check application will be submitted to the investigation agency selected by the College. The results of the investigation will be reviewed by the department chair/program director or dean. The College President, Vice President for Instruction, Vice President for Student Services, and the College's legal counsel may also have access to the background check results in certain situations, such as but not limited to, a student's removal from the nursing or allied health program due to the background check. Results of criminal background checks will be maintained in a locked space with immediate access only by the program director or dean.

The student understands that the nursing or allied health program must provide the results of the criminal background check to participating clinical agencies (hospitals, clinics, etc.), and that the student must be approved by those agencies before they are allowed to do clinical practice in the agency. Sufficient clinical practice is a requirement of the regulatory agencies governing health careers programs and students must have sufficient clinical practice to satisfy course and program objectives. Not being allowed to enter a clinical site makes it impossible for students to satisfy course and program objectives and therefore the student would be required to withdraw from the nursing or allied health program.

The student further understands that clinical agencies require proof of compliance with health and safety requirements including the individual's immunization record, which may include results of laboratory testing confirming immunity to certain diseases, results of urine drug screening, and results of testing for tuberculosis (skin test or recent chest x-ray). The nursing or allied health program director or dean or their designee will provide this information to the clinical agencies which request that such information be provided.

By signing and dating below, the student acknowledges that they have read and understands this policy and gives the nursing or allied health program permission to release information related to health and safety. Further, permission is granted to conduct the criminal background check.

APPENDIX A. REMOTE LEARNING

REMOTE LEARNING STUDENT CONDUCT AND EXPECTATIONS

During times when remote learning is established as the normal delivery of instruction, the following expectations and conduct will be enforced for all Odessa College nursing students. As an Odessa College nursing student, you are expected to uphold the policies and expectations, even while in the remote environment. Student engagement and participation is a requirement of our program and integral to your success.

STUDENT EXPECTATIONS DURING REMOTE INSTRUCTION

- Participate in the learning environment- Students are required to follow the guidelines set forth by their instructor. However, participation may include the following: using the chat feature to answer questions or ask questions, speaking to instructor and classmates when asked.
- Commit to treating the virtual environment as the face-to-face environment- Create a space for yourself away from distractions, as much as possible. Remove distracting stimuli (phone, music, TV). Do not engage in other activities while in the remote classroom (working, exercising, driving, cleaning). If a student is engaging in outside stimuli during the live lecture session, the instructor reserves the right to dismiss the students from the remote environment.
- Video should be turned on. Students are required to have video and audio capabilities. During your remote lecture sessions, students are required to have their video on for the duration of the lecture session. If the video is turned off, the instructor reserves the right to dismiss you from the class.
- Take responsibility and accountability for your learning. Check learning management platform frequently. Check student email frequently. Respond to instructor communications promptly. Ask questions when uncertain. Remain up to date on assignments.
- When entering the remote lecture session, mute yourself. Remain muted unless called upon or unmuted by your instructor.

STUDENT CONDUCT DURING REMOTE INSTRUCTION

As mentioned, during remote instruction, you are still held to the expectations and policies within the Nursing Handbook, as well as the Odessa College Student Handbook. Violations of standards, policies, and expectations will have the same consequences as a non-remote nursing student.

Communication during remote learning is crucial and should be done appropriately. When communicating with your instructor or nursing faculty, use your Odessa College student email account. Emails correspondence from outside sources is often sent to junk or quarantine email. Communicate professionally with the Odessa College nursing faculty, include your full name and the course name and number in which you are wanting to discuss.

Engagement in the classroom should also be professional, and specific to course work and course material. Remote learning communication is not private, never say, write or record anything that violates our handbook policies.

Academic Honesty and Integrity will be held with high regard in the remote learning environment. Be incredibly conscientious of the plagiarism and cheating standards set forth by Odessa College. Code of conduct violations and consequences will be followed for plagiarism and cheating.

For any disruptions or violations of our remote learning policies the instructor reserves the right to remove you from the remote live classroom.

ATTENDANCE DURING REMOTE INSTRUCTION

Students may be required to complete coursework following the safe learning requirements. During these

times, students will be conducting classes online and in person. We expect our students to maintain professionalism and respect for peers and instructor both during in person instruction and online instruction. The following will help to guide the student through their in-class instruction.

- Arrive on time, follow absence and tardy policies and instructions listed in handbook and syllabus.
- The camera must be on and able to show students through the entirety of the lecture session. If a student does not have their camera on and functioning, the student may be counted absent or receive a daily grade deduction.
- Follow instructor protocol and guidelines when your ability to follow the camera expectation is in question.
- Students are expected to be engaged in the online format as if they were in person. Alternative activities outside of the classroom material will not be allowed. Including but not limited to cell phone use, working on other material, driving or riding in a car, and other activities that portray a distraction to the students in their home learning environment.
- Students should be courteous to all other learners.
- Students should be expected to call and engage if called upon.
- Students should be expected to utilize the chat feature or any other online resource the instructor requests during class time.

If students are not following these guidelines they may be removed from the online lecture, marked absent or receive a grade reduction for that day.

REMOTE TESTING POLICY

While Odessa College is following social distancing guidelines, of which prevents students from taking exams on campus with their instructor, the nursing programs will be using HonorLock browser or other secured testing methods at the discretion of the instructor. Remote secure testing will require webcam and audio capabilities for each unit exam. The

following guidelines will ensure students proceed with no “flagged violations” during exams.

- No cell phones will be allowed during the exams. If students are seen with a phone during the exam, they will receive a failing grade for that exam.
- When completing the environment sweep before the exam, move the camera SLOWLY. Students are required to show the room and workspace in its entirety.
- The student’s face needs to be in the center of the frame before the exam and for the duration of the exam. If a student steps away from the camera, they are flagged. If the student moves the camera, they are flagged. If the student is out of frame (meaning the whole face is not visible) the student is flagged.
- Do not turn off the facial recognition alarm. This is designed to remind students of the program’s standards.
- Students are not allowed to use any form of notes or materials during the exam, unless written guidelines have been posted by the instructor.
- Students are required to bring a blank sheet of paper (show it is blank before proceeding), a writing utensil, and a calculator (phone calculators are NOT allowed).
- Please attempt to make each exam as close to a proctored setting as you are able. Remember the NCLEX will not allow reading outload, TV or music on in the background, or headphone during your exams.

If a student receives a “flagged violation”, the instructor and Director will determine the severity of the violation. If the violation is deemed inappropriate, the students will be subjected to a code of conduct violation and consequences of the written violation including but not limited to additional examination, probation, point deductions, dismissal from the nursing program.
